ORDER (ORAL)

Shri N.V. Krishnan.

All these cases are being taken up for disposal with the consent of the parties, as the issues involved are similar. The applicants were casual labourers in the Railways and after being engaged for some time they were disengaged. They, therefore, filed these O.As for a direction to the respondents to consider the regularisation of their service, in preference to the juniors and to further direct the respondents to reengage them in preference to their juniors until they are regularised for work on a casual basis.

2. The learned counsel for the parties submit that a similar matter has already been disposed of by this Bench in O.A. 2441/91 on 26.3.94 - Net Ram & Others Vs. G.M. Western Railway & Others. They request that these cases may also be disposed of on the same lines.

3. In view of this submission, we are of the view that these O.As can now be disposed of with similar directions as in the earlier case of Net Ram & Others (Supra).

4. Accordingly, these OAs are disposed of with a direction to the respondents to include the names of the applicants in the Live Casual Labour Register, if they are eligible for such inclusion in terms of the circular No. 220E/190-XIX-A/RIV, dated 28.8.1987 of the General Manager, Northern Railway (referred to in Net Ram's judgement) and give engagement to the applicants as casual labourers if and when the need arises, in accordance

with their seniority in that register. It is made clear that in order to enable the respondents to take such action, the applicants to submit representations to the competent authority within one month from the date of receipt of this order along with proof relating to the claim that they are entitled to be included in the Live Casual Labour Register and in case such representations are received, the respondents are directed to dispose them of in accordance with law within a further period of three months thereafter under intimation to the applicants.

5. The O.As are disposed of, as above.
6. As an order has been passed in these cases, these M.As have become infructuous.
7. Shri P.S. Mahendru, learned counsel for the respondents, would be entitled to fees in O.As 2688/91, 2860/92 and 2744/92 while Shri Romesh Gautam, learned counsel for the respondent, would be entitled to fee in O.A. No. 3216/92.
8. The original copy of this order shall be placed in O.A. 2892/92 and copies should be kept in each of the other O.As.
