O R D E R (Oral)

Shri V.P. Sharma, learned counsel for the  
applicant appeared on behalf of the applicants  
in all the above 8 OAs.

2. No memo of appearance has been filed and no  
reply has been registered on behalf of the  
respondents. However, Shri Romesh Gautam, learned  
counsel on behalf of the Railways is present here  
in connection with two other matters listed at  
Sl.No.22 and 23 of today's cause list, ie.OAs. 2743/92 and 109/92. His presence  
is noted in respect of these OAs, as desired by him. With the consent  
of both parties, these matters are taken up together  
for disposal by this common order.

3. We have heard the learned counsel for both  
parties. It is submitted that these OAs can be  
disposed of, on the lines of the earlier order  
in OA.2441/91 delivered on 26th May, 1994 in the  
case of Net Ram and others versus Union of India  
and others, by this Bench.

4. The applicants were casual labour employees in the Railways, who were engaged for some time, but were discontinued thereafter. The applicants have, therefore, prayed that they should be considered for regularisation and reengagement in preference to juniors and outsiders till such regularisation.

5. A similar matter Net Ram and others versus Union of India and others in OA.2441/91 was disposed of by this Tribunal on 26.5.94. The parties submit that all these OAs involve the same question and they can be disposed of, on the same lines.

6. In the circumstances, following the earlier decision, we dispose of all these OAs with the direction to the respondents to include the names of the applicants in the Live Casual Labour Register if they are eligible for such inclusion, in terms of the circular No.220-E/190-XIX-A/RIV dated 28.8.87 issued by the General Manager, Western Railway, referred to in that decision. The respondents are further directed to give engagement to the applicants as casual labourers if the need for such engagement arises, in accordance with their seniority in that Register. To enable such order to be passed, the applicants shall send their representations to the concerned competent authority within a period of one month from the date of receipt of a copy of this order, enclosing the necessary proofs relating to the claim that they are entitled to be included in the aforesaid Live Casual Labour Register. In case such representations are received, the respondents are directed to dispose them of, in accordance with law as stated

above, under intimation to the applicants within three months from the date of receipt of such representations from the applicants.

7. OAs are disposed of accordingly. No costs.
8. The applicants have filed MAs for disposing of the OAs on the basis of the earlier order in Net Ram's case. In view of the above order, the MAs stand disposed of.
9. The learned counsel for the respondents is entitled for the fees in the cases in which he has appeared.
10. This order shall be kept in OA.2448/91. A copy of this order be kept in all other OAs.
