These are four review applications, praying

for review of common judgment dated 2.6.95 in O.A.No.508/91 and O.A.No.432/91, and are being disposed of by this common order.

2. We have perused the contents of the review applications and it is manifest that the grounds taken therein do not bring them within the scope and ambit of Order 47 Rule 1 CPC, under which alone any decision/judgment/order of the Tribunal can be reviewed. In the guise of these review petitions, what is actually being sought is to appeal against the impugned judgment dated 2.6.95. This is not permissible.
