MA-1951/2004 is allowed, subject to just exceptions. Filing of joint application is permitted.




2. The applicants seek that they are entitled to the scale of Rs.8000-13500 in view of the nature, functions, job and greater responsibility being

performed by them they are entitled to the said scale. In this regard, they submitted a representation, which is at Annexure A-4. Since the representation is still pending and decision pertaining to the grant of scale has yet not been taken, it is directed that the respondent no.1 would consider the same and pass an appropriate order preferably within six months of the receipt of a certified copy of the present order and communicate it to the applicants.

3. At this stage, learned counsel for the applicants states that he may be permitted to file a supplementary representation. It is directed that if the applicants think it appropriate they may file within a fortnight a supplementary representation to the earlier representation.
