In both the matters, the applicants seek to restrain the respondents in notifying the proposed recruitment rules prescribing a particular limit of deputation/promotion which may affect their career prospects.

2. At this stage, admittedly the recruitment rules have not been notified. The grievance, if any, can only be considered and permitted to be raised once the recruitment rules are notified.

3. At this stage, the petitions therefore, must be held to be premature. Accordingly, they are dismissed as such. The applicants may make a grievance if and when the Rules come into being.
