

O R D E R (ORAL)

Justice V.S.Aggarwal:

Learned counsel for applicant states that since the matter is pending in the Delhi High Court whereby the penalty imposed has been challenged and the Writ Petition is still pending, he may be permitted to withdraw the present petition with liberty to take all the legal and factual pleas available to the applicant subsequently, including his seniority, after the decision of the Delhi High Court.
