ORDER

HON'BLE MR.S.R.ADIGE, VICE CHAIRMAN (A).

Applicants seek a direction to respondents to promote them to IES Gr.IV w.e.f. 1.10.90 with all consequential benefits including seniority in IES Gr.IV above Shri S.Lekshmanan and Shri Mohan Singh together with arrears.

2. We have heard both sides.

3. Shortly stated the dispute in question is as to whether respondents in denying applicants' claims have correctly implemented the directions contained in the Hon'ble Supreme Court's judgment dated 11.9.90 in B.S.Kapila & Ors. Vs. UOI & Ors. (CA No.4612-4614/90).

4. In this connection applicants' counsel Shri E.X.Joseph has invited our attention to the order No.11024/13/90-ISS dated 1.5.91 issued by the Department of Statistics Planning Commission in regard to appointments to Gr.IV Indian Statistical Service pursuant to the Hon'ble Supreme Court's directions in Kapila's case

(supra). That order dated 1.5.91 has been followed by a subsequent order No.11024/13/90-1SS dated 1.4.92. Copies of these orders are taken on record. It is not denied that the Indian Statistical Service Rules, 1961 administered by the Department of Statistics as the Cadre Controlling Authority and the Indian Economics Service Rules, 1961 administered by the Department of Economic Affairs as the Cadre Controlling Authority are more or less identical as far as the issues involved in this case are concerned, and Shri Joseph has emphasised that applicants in the present case are only seeking the implementation of the Hon'ble Supreme Court's directions in Kapila's case (supra) in regard to promotions to Gr.IV of IES in the same manner as the Department of Statistics has implemented the aforesaid directions in regard to promotions to Grade IV of ISS.

6. In this connection another order relied upon by him is dated 18.2.93 pronounced by CAT PB in OA No.2004/92 R.B.Gupta Vs. UOI & Ors. which also relates to promotion to Gr.IV of ISS in the background of the Hon'ble Supreme Court's directions in Kapila's case (supra).

7. Nothing has been shown to establish that the aforesaid orders dated 1.5.91 and 1.4.92 issued by the Department of Statistics have been withdrawn, superceded, or struck down or that the CAT PB order dated 18.2.93 in R.B.Gupta's case (supra) has been



stayed, modified or set aside. It is clear that the IES Rules, 1961 and the ISS Rules, 1961 being more or less identical in regard to the issues involved in this case, two departments of Govt. (Deptt. of Economic Affairs and Deptt. of Statistics) cannot, without good reason, interpret the same directions viz. Hon'ble Supreme Court's directions in Kapila's case (supra), differently.

8. In the facts and circumstances, noticed above, this OA is disposed of with a direction to respondents to consider the claims of applicants for promotion to Grade IV of IES w.e.f. 1.10.90 and with grant of appropriate seniority in the background of the orders dated 1.5.91 and 1.4.92 passed by the Deptt. of Statistics in regard to similar claims for promotions to ISS w.e.f. 1.10.90 and pass a detailed, speaking and reasoned order thereon in accordance with rules and instructions as expeditiously as possible and preferably within 4 months from the date of receipt of a copy of this order. While doing so, respondents shall also not lose sight of the Tribunal's order in R.B. Gupta's case (supra). Consequent to the implementation of these directions such of those applicants who are promoted to Gr. IV of IES w.e.f. 1.10.90 with appropriate seniority, shall be entitled to consequential benefits flowing therefrom in accordance with rules and instructions.

9. This OA is disposed of in terms of para 8 above. No costs.
