The applicants are aggrieved that they have been subjected to hostile discrimination by the respondents by denying them 30% now reduced to 15% incentive allowance as granted to other officials of the Advanced Level Telecom, Training Centre (ALTTC) which is a department under the respondents. The applicants in O.A. 58/92 submit that they constitute the Staff holding the posts connected with the Course Development, Media Support, Audio Visual Printing Training Material, Laboratories, Exchange and systems and maintenance of Hostels which constitute indispensable ingredient of the entire training imparted by the ALTTC. In the other O.A. 2374/91, the applicants are Senior Section Supervisors/Telecom Office Assistants who are looking after the administration and economic work of the ALTTC and they are also aggrieved that they have been denied the incentive allowance. These applicants also state that they have been transferred in different years and posted at ALTTC but they are neither getting any faculty/teaching allowance nor any incentive for their work nor they are treated as deputationists in that organisation getting deputation allowance/special pay.

2. As the issues involved in these two Original Applications are similar, they have been taken up together for disposal by a common order. Both the parties rely on the Office Memo issued by the DOP&T dated 7.2.1986. The applicants are claiming that they are entitled to 30% incentive allowance as provided therein which is denied by the respondents. It would, therefore, be useful to see this

O.M. in detail in the first instance. Para (i) of the O.M. states that an incentive scheme has been drawn up to cover the training institutions meant for Grade 'A' officers. Relevant part of Para (ii) provides that with regard to faculty members who join the training institutions on deputation, their emoluments may be raised by 30% of the total emoluments which they would be getting in their cadre, while posted in the field. The respondents have submitted that the provisions of this scheme were extended to other training centres meant for training officials w.e.f. 1.1.1987. In O.M. dated 21.1.1987 Respondent 1 had laid down the guidelines for grant of incentive allowance to the faculty members of the training institution, namely, ALTTC Ghaziabad and TTC, Jabalpur. According to the applicants, the list prepared by the respondents is not confined only to those who are engaged in Instructional/Teaching work but includes others who got the 30% incentive allowance. They claim that in that event there is no reason why they, who are also undoubtedly assisting in teaching work in the ALTTC should not be given the incentive allowance as given to the faculty/teaching members. In the circumstances, they have stated that the respondents are guilty of hostile discrimination against them as many members of the staff who are not faculty members and who are not doing any teaching/instructional duties are granted 30% incentive allowance. They have given a list of the names of officials who are getting this allowance who are not faculty members and not doing teaching and instructional work (A-19) but are only in administration or supporting staff and doing similar work as the applicants. They state that while persons given in the list get the allowance, the applicants are denied the same even

though they are also in the category of supporting staff. In O.A. 58/92, Shri E.X. Joseph, learned Senior Counsel, has submitted that while, for example, most of the staff involved in maintenance of supply of electricity to the entire Campus are granted the incentive, in some other cases, persons doing the same work in the same department like maintenance of records of building and allotment of quarter, only one Shri Chunni Singh, SDE, is granted the incentive and Ms. S.B. Saxena, TS is not given the same which shows that the whole scheme is administered arbitrarily by ALTTC. Similarly, Shri B.B. Raval, learned counsel for the applicants in O.A. 2374/94 has also submitted that the applicants who are Telecom Assistants are supporting staff to the Faculty Members should not be discriminated in payment of the incentive allowance when other persons have been granted this allowance who are also not performing teaching/instructional duties. He has also submitted that the applicants have been sent from the parent department to ALTTC Ghaziabad and so they are also entitled to deputation allowance.

3. The respondents in their replies to the aforesaid applications have denied that the applicants are entitled to the incentive allowance. They have submitted that the applicants in O.A. 58/92, are Hindi Translators, Personal Assistants, Telephone Operators, Linesmen, Drivers etc. who do not belong to the cadre of trainers. They have submitted that no selection process is involved in their posting to the training Centres and their nature of work and duties are not of a specialised nature which justifies payment of 30% incentive allowance which is paid to faculty/teaching staff. They have referred to the

guidelines issued by the DOP&T letter dated 20.6.1986 which states that obviously this facility should include all teaching/instructional staff including officials engaged in Lab-demonstrations and practicals eg. Cable jointers. However, this should not include the staff like peons, chowkidars, drivers and stenos, etc. They have also relied on the decision of the Tribunal in O.A. 227/87 (Jabalpur Bench) wherein it has been observed that the applicants who belong to the category of Ministerial staff by no stretch of imagination can be treated as members of faculty of the teaching staff....If the Government of India, Department of Personnel and Training has given the benefit of the incentive scheme only to the teaching staff and not extended to the ministerial staff, no constitutional discrimination is attracted. Accordingly, the application was dismissed. Shri V.S.R. Krishna, learned counsel, has submitted that as some category 'B' officers are also engaged in imparting training, as also technicians who have demonstration work in the laboratories, they are being paid 30% incentive as per the guidelines of the DOP&T letter dated 20.6.1986 and there is no illegality in this.

4. M.A.958/97 has been filed by the applicants in O.A.58/92 seeking a direction to the respondents to file relevant official documents in respect of time tables of instructional duties, classes, allotment and assignment of instructional duties to various officers. In the reply filed to the M.A. the respondents have submitted that the applicants who are drivers, stenos, etc. have filed Miscellaneous Applications repeatedly without any cause of action. They have further submitted that the grant of incentive allowance which was originally 30%, now reduced to

15%, is restricted only to those personnel who are performing instructional duties. So far as the allegation that certain officers/officials who are not performing any instructional duties are being granted training allowance is concerned, they have reiterated that this benefit cannot be extended to the applicants merely on the ground that it is erroneously being allowed to others as alleged by the applicants. Shri V.S.R. Krishna, learned counsel for the respondents, has submitted that it may be that in the list relied upon by the applicants which has been referred to in the reply to MA 958/97 certain officers/officials might have received this incentive allowance wrongly. He has explained that some of these officials have been kept in the faculties where no instructional duties are performed at present but who can also be allotted instructional duties whenever required in the courses run by other faculties. He further submits that even if some of these officials have been wrongly granted incentive allowance, that by itself cannot support the claim of the applicants to be given similar allowance even if they are not doing teaching/instructional duties or are covered under the DOP&T O.M. dated 7.2.1986.

5. We have seen the relevant judgements of the Tribunal(Principal Bench) in O.A.712/86 and 1628/90, decided on 30.11.1990 as well as O.A. 2006/92, decided on 18.1.1993. In the order of the Tribunal dated 30.11.1990, it is stated that the applicants are discharging instructional duties in ALTTC, Ghaziabad and so they are entitled to get instructional allowance w.e.f. 1.1.1987 and also entitled to draw special pay w.e.f. 1.4.1986. The

Tribunal had examined similar issues as have been raised before us in O.A.2006/92 in which it has been stated as follows:

".....No direction as such can be given in the matter by the Bench since it would not be appropriate for the Bench to examine the nature of work being done by the Hindi Officers and the Faculty Members and other officers imparting training. The matter is left to the consideration of the respondents themselves with no legal direction as such in the matter. It is for the respondents to take into account factors such as the nature of training imparted by Hindi Officers, the examination conducted by them during the course of the instructional training, the recommendation of the C.G.M. the concurrence of I.F.A. mentioned in Annexure A-3 and all other relevant factors.

5. With the above observations, the case is disposed of with no order as to costs".

In O.A. 58/92 also some of the applicants are Senior Hindi Translators but what further action was taken by the Respondents in the light of the above observations of the Tribunal has not been placed on record.

6. From a perusal of the O.M. issued by the Department of Personnel and Training dated 7.2.1986, it is clear that the intention of the Government was that with regard to faculty members who join the training institutions on deputation, their emoluments may be raised by 30% of the total emoluments which they would be getting in their cadre while posted in the field. The guidelines issued with respect to payment of 30% incentive to faculty members have clarified this position. The applicants in these two applications are no doubt supporting staff/^{but}are not involved in teaching/instructional duties as such. However, we note that in respect of certain officials working in ALTTC, Ghaziabad the respondents have granted them 30% allowance

which they have not been able to fully justify on the basis of the DOP&T O.M. dated 7.2.1986 and guidelines including the letter dated 20.6.1986 as they are not involved in teaching/instructional duties. In this context, we note the submissions made by Shri V.S.R. Krishna, learned counsel for the respondents that merely because some of the officials who are not doing instructional duties have been given incentive allowance wrongly does not give an enforceable right to the applicants to claim similar benefits under the Scheme of DOP&T dated 7.2.1986. We are constrained to observe that the respondents have not strictly adhered to the DOP&T Scheme for payment of incentive allowance to their officials posted at ALTC. The Scheme was meant to apply only to Faculty Members who are involved in instructional/teaching duties and cannot, therefore, include persons like Peons, Drivers, Telephone Operators, etc. who are not discharging such functions. In this view of the matter, we do not think that there is any hostile discrimination against the applicants or that the Scheme for incentive allowance which was originally 30%, now reduced to 15%, is applicable to the applicants who admittedly are ^{only} supporting staff and not performing teaching/instructional work in ALTC, Ghaziabad. The applications (O.As 58/92 and 2374/91), therefore, fail, as also MA 957/97.


7. From the submissions made on behalf of the respondents, it is clear that the Scheme dated 7.2.1986 read with the letter dated 20.6.1986 has not been properly implemented by Respondent 3 - ALTC, Ghaziabad. When the Court/Tribunal comes across that an other-^{wrongly} wise laudable order is being implemented and its perpetuation shall result in further miscarriage of justice, then the duty is cast on them to rectify the error and put the order back on the original track for the purpose of implementation (See **S. Nagraj Vs. State of Karnataka** (1994 SCC (L&S) 320). We are facing the same situation here. As it is a matter of public interest, we consider it necessary to issue a direction to Respondents 1, 2 and 4 to take appropriate

remedial action in accordance with the Scheme at the earliest, and in any case within three months from the date of receipt of a copy of this order and to ensure that such lapses do not occur.

We have also considered the other submissions made in the applications, particularly in O.A. 2374/91 regarding deputation allowance but find no materials on record to support this and it is accordingly dismissed.

8. As we find no merit in these applications (O.As 58/92 and 2374/91) they are accordingly dismissed. No order as to costs.
