O.A.

2. We have heard Shri Sharma, applicant's counsel. None appears for the respondents.
3. We note that none has been appearing for the respondents since 5.4.99 onwards.

4. Applicant's counsel Shri Sharma has stated that the matter <sup>stands</sup> ~~admittedly~~ simplified consequent to the Hon'ble Supreme Court judgement in J.N.Goel and others Vs. Union of India and others (AIR 1997 SC 729) and further states if the respondents implement the aforesaid judgement of the Hon'ble Supreme Court, the applicants grievances would have been resolved.

5. Article 144 of the Constitution lays down that all authorities, civil and judicial, in the territory of India shall act in aid of the Supreme Court, and under Article 141 the law declared by the Supreme Court shall be binding on all courts within the territory of India.
