The applications having been heard on 04.12.1996 the Tribunal on the same day delivered the following:

ORDER

Chettur Sankaran Nair(J), Chairman

Applicants before us are 'artists' seeking regularisation of their services. They work as Carpenters/Painters and in other capacities and it is slightly incongruous to call them artists. Be that as it may, they have been working for long years in activities integral to the work of the Doordarshan. Therefore, they submit that their services may be directed to be regularised.

We find that the authorities of the Doordarshan have framed a scheme for regularisation/absorption of casual 'Artists'. We direct respondents to consider the request of applicants for regularisation in terms of the Scheme and in relation to their position in the priority list and the job requirements.

Counsel for applicants expressed the fear that the applicants may be substituted with outsiders. We are not inclined to take this apprehension or

misapprehension seriously because the law laid down in  
State of Haryana & Ors. Vs. Piare Singh & Ors. (AIR  
1992 SC 2130) does not leave room for doubt in these  
matters.

With the aforesaid direction, we dispose of  
the applications. No costs.
