O R D E R (ORAL)

Applicants are Sweepers in Delhi Police and their main grievance is that they are continuing to stagnate as such, without any opportunity for career advancement throughout their service career.

2. We have heard Shri V.P.Sharma, learned counsel for the applicants and Shri Jog Singh, learned counsel for the respondents.

3. Learned counsel for the applicants has stated that applicants would be satisfied if a direction is issued to the respondents on the lines contained in the Tribunal's order dated 12.3.99 in O.A.No.1843/93 (Harish Chander & ors. vs. Union of India & ors.). In this connection, the learned counsel for the applicants has invited our pointed attention to the Hon'ble Supreme Court's judgement in the case of C.S.I.R. & anr. vs. K.G.S.Bhatt & anr. - (1989) 4 SCC 635, in para 9 of which it has been observed as follows:

"He was however, left without opportunity for promotion for about twenty years. This is indeed a sad commentary on the appellant's management. It is often said and indeed, adroitly, an organisation public or private does not 'hire a hand' but engages or employs a whole man. The person is recruited by an organisation not just for a job, but for a whole career. One must, therefore, be given an opportunity to advance. This is the oldest and most important feature of the free enterprise system. The opportunity for advancement is a requirement for progress of any organisation. It is an incentive for personnel development as well. Every management must provide realistic opportunities for promising employees to move upward...."

4. In the facts and circumstances of this case, we dispose of this O.A. with a direction to the competent authority that in the event applicants submitted self contained representation to the respondents within four weeks from the date of receipt of a copy of this order, respondents will consider the same in the light of the rules/instructions and judicial pronouncements on the subject and pass a detailed, reasoned and speaking order

thereon under intimation to applicants within six months from the date of receipt of the representation. The O.A. stands disposed of accordingly. No costs.
