



O R D E R (Oral)


By this O.A filed under section 19 of the Administrative Tribunals Act, 1985, the applicants, who are 16 in number, have challenged the order dated 17.10.1997 by which respondents have directed to withdraw the temporary status and to recover the amount illegally paid to them. A copy of the order has been filed as annexure- 1. The correct dated of the order is 17.01.1997 which has been wrongly mentioned in the relief clause as 17.10.1997.

2. From perusal of the order it is clear that it does not refer to the applicants in any manner either with regard to withdrawl of the temporary status or with regard to recovery of any amount. The order has been passed in context with one Sri Narendra Kumar who had filed O.A No. 107/95. In the circumstances, there is no question for interference by this Tribunal at this stage.



3. Learned counsel for the applicant however, submitted that the Lucknow Bench of this Tribunal in O.A No. 551/94 and 555/94, which have been decided on 27.04.2001 by a Division Bench, has taken view that temporary status cannot be withdrawn nor the amount can be recovered. A copy of the judgment has been placed before me. As there is no order on record <sup>& indicating</sup> ~~undertaking~~ that any step has been taken against the applicants regarding recovery of the amount or withdrawal of the temporary status, no interference is required. However, it is left open to the applicants to place the order dated 27.04.2001, if any such step is taken by the respondents in future.

4. Subject to aforesaid the O.A is disposed of finally with no order as to costs.
