O R D E R (oral)

(By Hon'ble Mr. Justice R.R.K. Trivedi, V.C)

By this application under section 19 of the Act, applicants have challenged the order of transfer dt. 08.05.97 (annexure A- 1) by which certain employees of the Electric Locomotive <sup>have been transferred to</sup> Ghaziabad from Allahabad Division <sup>of</sup> under control of Delhi Division w.e.f 01.06.97. Order also speaks about maintenance of the separate seniority list of the employees transferred on different division to Ghaziabad. Against this order applicants filed detailed representation on 28.07.97, a copy of which has been annexed as annexure A-14. The grievance of the applicants is that though options were invited from the applicants but no decision has been taken <sup>by</sup> either on the option submitted by the applicants <sup>or</sup> representation filed by them has been decided though various reminders were given. Latest reminder was given on 22.05.97.

2. Considering the facts and circumstances of the case since the applicants have already <sup>been</sup> approached the appropriate authority who is competent to grant reliefs to the applicants, <sup>in</sup> my opinion this Tribunal <sup>should</sup> ~~not~~ interfere at this stage, except for the direction to respondent No. 6 to decide the representation of the applicants expeditiously within the specified time as it is pending for last three years. Accordingly the O.A is disposed of finally with the direction to respondent No. 6 to decide the representation of the applicants by reasoned order within three months from the date a copy of this order is filed before him. It is made clear that

before passing order applicants shall be heard on various issues raised out of the transfer. In order to avoid delay it is also <sup>permitted</sup> ~~directed~~ to the applicants to file a fresh representation alongwith copy of this order.
