to respondent No.1 to give promotional benefits on time bound basis to the applicants. The applicants are also aggrieved by order dated 27.09.1996 by which their representations were rejected by the respondents.

2, Shri G. R. Gupta, counsel for the respondents has submitted that on the basis of recommendation made by ^{on Pay} Vth Commission, Govt. of India has already introduced ~~the~~ scheme known as A.C.P. Scheme, ^{on two} which ensures minimum ~~the~~ promotional upgradation in the pay-scales, during the service career of the employee, if they satisfied the condition provided therein. This scheme has come into force in 1999 and applies to the organisations ~~of~~ ^{on under} the defence department also.

3. Considering this development, in our opinion, the interest of justice will be served, if this O.A. is disposed off finally with a direction to respondent No.2, Engineer-in-Chief Army Headquarter, New Delhi, to consider the case of the applicants for benefits under ACP scheme, if they satisfied the condition provided therein.

4. The O.A. is accordingly disposed off finally with a direction to respondent No.2 to consider the claim of the applicants for benefits under ACP scheme introduced by Central Government in accordance with law. No order as to costs.
