

JUSTICE B.C.SAKSENA, V.C.

Through this OA the applicant has prayed for cancellation of advertisement dated 29.3.97 issued by the Central Public Works Department for the recruitment of the Junior Engineers. In the said advertisement the age qualification is as on 1.7.97 the candidate should be between the age of 18 years and 25 years for general candidates. The applicant seeks cancellation of the advertisement on the ground that in other departments the age prescribed is 33 years. This is a policy decision and it is upto the department to lay down the requirement of age keeping in view the requirement of the posts in question. The relief prayed for therefore cannot be granted. The OA fails and <sup>as</sup> accordingly dismissed summarily.
