O R D E R (O_r_a_l)

By Hon'ble Mr. Justice RRK Trivedi, V.C.


By this OA filed under Section 19 of the Administrative Tribunals Act, 1985, the applicants have prayed for a direction to the respondents to re-engage the applicants as casual labour and regularise their services on the basis of position of their names in the Live Casual Labour Register. The basis of the claim is that the applicants had worked for 240 days before 1981. In support of this claim the applicants have filed certificates issued to them which show that they worked sometime in 1978-79. This OA has been filed on 22-9-1997 i.e. after about 18 years. Sri Amit Sthalekar, learned counsel for the applicant has submitted that the certificates filed are totally vague and uncertain. The

Railway does not possess any ^{at record or} ~~certificate~~ about work of the applicants and the application is highly time barred and likely to be rejected on this ground of limitation.

2. Learned counsel for the applicant on the other hand submitted that the cause of action arose to the applicant in 1993 after the judgement of this Tribunal in OA No.73 of 1992 - Baij Nath and Others. Even if the submission of the Learned Counsel for the applicant is accepted for the sake of arguments, the long delay has not been explained as this OA has been filed in 1997 i.e. after four years of 1993 judgment. In the circumstances the applicants are not entitled for any relief as the relief claimed is barred by time. Accordingly ^{the application is a} dismissed as barred by limitation. There shall be no order as to costs.
