O R D E R

HON'BLE MAJ GEN. K.K. SRIVASTAVA, MEMBER-A

In this O.A. filed under section 19 of Administrative Tribunals Act 1985, the applicants have prayed for direction to the respondents for proper fixation of salary in the scale of pay of Rs.260-400/- (Pre revised) from the initial date of appointment of the applicants as per Government order dated 16.11.1981 and pay the arrears on re-fixation in the revised pay scale. They have also prayed for direction to the respondents to give consequential benefits.

2. Shri R. Trivedi, learned counsel for the applicant submitted that the applicants were appointed during 1983 and 1985 on the post of Tailor (Skilled in the establishment of respondent no.3) and they were not aware about the order of the Government of India dated 16.10.1981. Inviting our



attention to para 6, the learned counsel submitted that the applicants are entitled for revised scale. The applicants came to know about the existence of order dated 16.10.1981 (Annexure A-1) only in 1997 and then the applicants filed various representations before the respondents for proper fitment of salary of the applicants. However, the respondents did not take any decision on the representations filed by the applicants and, therefore, they filed this O.A.

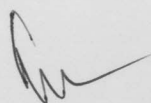
3. The learned counsel for the respondents opposing the claim of the applicants submitted that the O.A. is liable to be dismissed on the ground of limitation because the applicants want to take advantage of the circular of the Government of India, Ministry of Defence, dated 16.10.1981 (Annexure A-1) by filing this O.A. in 1998 after having served in the department for more than 13 years.

4. The learned counsel for the respondents further submitted that at this belated stage no relief can be granted to the applicants.

5. We have heard counsel for the parties, considered their submissions and perused records.

6. We have carefully perused the circular of the Government of India dated 16.10.1981 (Annexure A-1) para 6 of the said circular Rules as under:-

"6. In certain cases, where the fitments result in down-gradation of jobs, incumbents thereof should be allowed to draw pay in the existing scales of pay till they are wasted out or promoted to the next higher post. Future entrants/promotees (to these jobs) should, however, be given the revised scale."

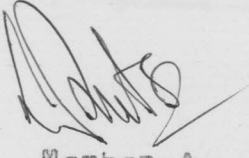


7. From the above, it is clear that the circular would be applicable in the case of applicants who were the future entrants. We, therefore, consider it appropriate in the interest of justice to direct the applicants to file a representation before the competent authority within three weeks and the competent authority to decide the same within specified period.

8. In the facts and circumstances, we dispose of this O.A. by giving liberty to the applicants to file a fresh detailed representation before the competent authority within three weeks and the competent authority shall decide the representation of the applicants by a detailed and reasoned order within a period of three months from the date such representation alongwith the order of this Tribunal is filed before him.

9. There shall be no order as to costs.
