ORDER (U r a l)

This DA has been filed for a direction to the respondents not to appoint any person from direct market and absorb the applicants on the basis of their merit when vacancies exist. The applicants also seek setting aside of the order dated 15-9-2001.


2. Learned counsel for the respondents has been heard as he is present today. There is no prayer for adjournment of learned counsel for the applicant.


3. The impugned order was passed on account of a direction given by this Tribunal in DA No.706 of 2001 on 30-7-2001 directing respondent no.2 to decide the representation of the applicant in the DA by a speaking order within a period of two months. The applicants who are duly qualified trade apprentices, claim to have



received proficiency in the trade of Hand Compositor, Book Binder, Engraver, Machine Minder, Mono Key Board Operator, Process Cameraman, Lithographer, Plate Maker and Retoucher and claim to have appeared in trade test in 1991 and qualified in three different Batches, No. 58, 56 and 59. The applicants had in that DA sought a direction to the respondents to absorb them in vacancies in preference and not to appoint any person from open market till all are absorbed. The direction was ~~to be~~ given to respondent no.2 to decide the representation by a reasoned and speaking order within two months. We find that respondent no.2 has now decided the representation which is impugned in this case before us. Respondent no.2 has explained that as far as recruitment in the Printing Press is concerned, due to induction of new technologies, trades like Letter Press Machine, Hand Composing Book Binding, and Engraving etc. have become obsolete. It is stated that recruitment through competitive open market, selection in Group 'D' has not been resorted to in the Press during the last decade. Besides 76 skilled and supervisory jobs in the relevant out-dated trades have been declared obsolete by the Controller of Stores, North East Railway as a result of which staff has been rendered surplus and is awaiting redeployment. Respondent no.2 has also stated in his order that guidelines laid down by the Hon'ble Supreme Court would be followed and they would be given preference as and when fresh recruitment in their relevant trades takes place.

4. We find no infirmity in the order. We, therefore, dismiss the DA as lacking in merits. No costs.
