The applicants have filed this OA seeking direction to the respondents for regularisation of their services against regular post and after having acquired temporary status.

2. The applicants claimed that they have been working in the office of the respondents for more than last ten years with short breaks in service. However, their services have not been regularised by the respondents. In this context, the applicant submitted their representation dated 06.06.2001 (Annexure A-6 to the OA) to the General Manager, Bharat Sanchar Nigam, Moradabad and the same is still pending for consideration and for suitable orders.

3. Learned counsel for the applicant submitted that direction may be issued to the respondent no. 4 General Manager, Bharat Sanchar Nigam, Moradabad Division, Moradabad to consider and pass appropriate order on their representation within stipulated period.

4. The OA is accordingly disposed of with the direction to respondent no. 4 to consider the representation of the applicants and pass appropriate order within a period of 2 months from the date of communication of copy of this order. No order as to costs.
