O R D E R

The applicants two in number have challenged through  
this O.A. the selection of respondent No.3 to the post of  
Commercial Inspector <sup>vide order</sup> dated 15.10.2004. Earlier, the office

of Divisional Railway Manager, Varanasi issued notification dated 30.06.2004 inviting applications from eligible and desirous candidates to fill up the 8 posts of Commercial Inspector out of which 70% were to be filled up from amongst Sr. Commercial Clerks, 10% from amongst inquiry-cum-reservation clerks and 20% from amongst Senior Clerks (Commercial). As per the said notification, 5 posts were to be filled up from amongst Sr. Commercial Clerks, one post from amongst inquiry-cum-reservation clerk and 2 posts from amongst Sr. Clerks (Commercial). Pursuant to the notification dated 30.06.2004<sup>of</sup> the D.R.M. (P) N.E. Railway, Varanasi, 22 candidates had applied to appear in the written test.


2. The applicants have challenged the selection on the ground of favouritism and nepotism in as much as two candidates namely one Shri Navin Prakash who had not applied/found eligible and one Satya Prakash Singh, Senior Ticket Collector were allowed to appear in the examination.

3. Counsel for the applicant states that he will be satisfied if the applicant is directed to submit their representation to the competent authority in North Eastern Railway to seek redressal of his grievance. Accordingly, the applicants<sup>are</sup> directed to submit representations highlighting their grievances to DRM, North Eastern Railway, Varanasi within a period of 15 days from the date of receipt of a copy of this order. Respondent No.2 D.R.M. North Eastern Railway, Varanasi is directed to decide the representation of the applicants within a period of 3 months from the date of receipt of a copy of the judgment along with the representations of the applicants by passing a reasoned and speaking order under intimation to the applicants.
