ORDER

By Hon'ble Mr. A.K. Gaur, Member-J :

It has been contended by learned counsel for the applicant that against the dispute of seniority the applicants have already ~~been~~ [✓] preferred a representation dated 28.08.2005 (Annexure-A-5) to the competent authority but the same has not been considered and decided as yet. Learned counsel for the applicants would contend that their grievance might be redressed, in case a direction is given to the competent authority to consider and decide the pending representation dated 28.8.2005 (Annexure-A-5) of the applicants by a reasoned and speaking order within a specified period of time.


2. Accordingly, we hereby direct the respondents/competent authority to consider and decide the pending representation dated 28.08.2005 (Annexure-A-5) of the applicants by a reasoned and


