



The applicants (21 in number) who are P. Way Supervisors under Divisional Railway Manager, Northern Railway, Moradabad Division, Moradabad have impugned provisional seniority list dated 07.03.2005. The impugned seniority list, according to the applicants, has disturbed the seniority of the applicants by placing the juniors of the applicants higher in the seniority list. As a result the seniority of the applicants has been brought down without any rhyme and ~~region~~ <sup>Reason</sup> being marred by illegalities and arbitrariness.



2. In support of their contentions, the applicants have enclosed provisional seniority list dated 23<sup>rd</sup> May 2003 (Annexuire-2) for the post of P. Way Supervisor in the pay-scale of Rs.4500/- to 70000/- issued by the office of DRM, Northern Railway, Moradabad. The applicants have no grievance of any kind against the seniority listed dated 23.05.2003.

3. - We have heard counsel for the parties and are of the view that the applicants will file separate representation addressed to the competent authority who will decide the same within a stipulated time frame. Accordingly, the competent authority ~~to~~ <sup>will</sup> decide and disposed <sup>✓</sup> off the representations by making a detailed and speaking order under intimation to the applicants within a period of 3 months from the date of receipt of a copy this order along with the representation of the applicants.
