**ORDER**

**By Hon'ble Mr. S. C. Chaube, Member (A)**

The applicant who was posted as compositor Gr.I North Eastern Railway Printing Press has impugned order dated 05.07.2005 passed by the Chief Material Manager (Printing & Technology), Office of Store Controller, N. E. Railway, Gorakhpur thereby removing the applicant from Railway Service with immediate effect.

2. Briefly, the facts are that the applicant at the time of joining of Railway Service furnished his date of birth as

26.12.1948 on the basis of transfer certificate issued by Shri Nirankar Vidyalaya Gorakhpur. A departmental enquiry was conducted. The charge against the applicant was that he had actually studied in D.B. Inter College as per record <sup>of</sup> ~~kw~~ which his date of birth was 04.08.1942. However, at the time of entering Railway Service he mentioned his date of birth as 26.12.1948 based on a fake transfer certificate issued by Shri Nirankar Vidyalaya Gorakhpur.

3. During the enquiry the charges against the applicant could not be substantiated and therefore, the disciplinary authority exonerated him from the charges leveled against him vide order dated 21.07.2004. Thereafter the Chief Material Manager, vide his order dated 11/19.01.2005 issued a show cause notice to the applicant calling for his explanation regarding manipulation of date of birth by the applicant from 04.08.1942 to 26.12.1948. The applicant vide his explanation dated nil (Annexure A-5) sent his explanation to chief Material Manager Office of Store Controller, North Eastern Railway, Gorakhpur who after carefully evaluating the submission made by the applicant ordered his removal from Railway Service vide order dated 05.07.2005.

4. We have heard counsel for the parties and perused the petition. Learned counsel for the applicant stated that he would be satisfied if a direction is issued to the Revisionary Authority to consider and dispose of the representation filed by the applicant within a stipulated time frame. Accordingly the applicant is directed to file a representation by way of revision before the competent




