1. Learned Counsel, Mr. M S Trivedi for the applicants submits that by way of representation dated 16/10/2018, the applicants had requested the Competent Authority to consider their claim for grant of anti-dated promotion, the said remains unanswered till date. Hence this OA. It is stated that the prayer sought in this OA is identical therefore has filed separate application being MA No. 340/2021 for allowing them to file OA jointly.
