### **ORDER (ORAL)**

**PER: SURESH KUMAR MONGA, MEMBER (J)**

At the very outset, Shri Thukarama Rao, learned counsel for the petitioners, submitted that Writ Petition No. 12907/2020 has been dismissed by the Hon'ble High Court of Karnataka at Bangalore on 05.03.2021 and the order dated 20.08.2019 passed by this Tribunal in OA No. 170/01465-01493/2018 stands affirmed. Learned counsel further submitted that a further direction has also been issued to respondents to release the arrears of NPA in favour of the petitioners within a period of 90 days from the date of receipt of a certified copy of the said order.

2. In view of the above, the Contempt Petition is disposed of with liberty to the petitioners to get the same revived in the eventuality of failure of the respondents to abide by the directions issued by the Hon'ble High Court in its order dated 05.03.2021 passed in Writ Petition No. 12907/2020.
3. Rule of the Court is discharged.
