**ORDER (ORAL)**

**PER: SURESH KUMAR MONGA, MEMBER (J)**

The present Original Application has been filed by the applicants under Section 19 of Administrative Tribunals Act, 1985 making therein the following prayer :

*“(b) This Hon’ble Tribunal be pleased to issue a writ of mandamus directing the respondents to grant Non-Functional Grade (NFG) Scale in the Pay Band-2 – Rs. 9300- 34800+ GP of Rs. 5400/- after completion of 4 years of service to the applicant in Pay Band-2 Rs. 9300- 34800/- + GP Rs. 4800/-, with all consequential benefits of arrears of pay, pay fixation.”*

2. At the very outset, Shri. BS Venkatesh Kumar, learned counsel for the applicants submitted that the matter is squarely covered by a judgement dated 30.01.2020 rendered by this Tribunal in OA No. 746/2019. Learned Counsel further pointed out that the said judgement has already been implemented by the respondents vide order dated 21.04.2020.

3. The fact as stated by Shri. BS Venkatesh Kumar, learned counsel for the applicants has not been disputed by Shri. NB Patil, learned counsel for the respondents.

4. Accordingly, the OA is allowed in the same terms of the judgement dated 30.01.2020 rendered by this Tribunal in OA No. 746/2019.

5. Consequent thereto, the respondents are directed to release the benefits to applicants herein within a period of two months from the date of receipt of a certified copy of this order.
