O R D E R (ORAL)

1. The present Original Application has been filed by the applicant against an order dated 23.12.2020 vide which Ashok R Patil, Deputy Conservator of Forests, Vijayapura Division, Vijayapura (Respondent No. 7 herein) has been ordered to be transferred and posted as Deputy Conservator of Forests, Ghataprabha Division, Gokak, vice S J Chandrashekhar (the applicant herein).
2. During the course of hearing, it has emerged that the Respondent No. 7 is due for retirement on 31.07.2021. It has also been brought to our notice that after issuance of the order dated 23.12.2020, the applicant herein gave a representation to official respondents on which no decision has been taken upto now.
3. In view of the facts and circumstances of the case, more particularly, the factum of retirement of Respondent No. 7 on 31.07.2021, we deem it appropriate to dispose of the present Original Application without entering into the merits of the case with a direction to official



respondents to revisit the order dated 23.12.2020.

4. Accordingly, the Original Application is disposed of with a direction to the competent authority to revisit the order dated 23.12.2020 and issue the fresh orders with regard to posting of the applicant herein. Before taking such a decision, the applicant shall also be afforded an opportunity of hearing. All the pleas raised by him in his representation dated 24.12.2020 shall be taken note of.
5. The whole exercise shall be undertaken on or before 31.07.2021 i.e. the date of retirement of Respondent No. 7 herein.
6. Ordered accordingly. However, there shall be no orders so as to costs.
