## **O R D E R(Oral)**

**Per: SURESH KUMAR MONGA, MEMBER (J):**

1. Sh. Onkar Rai, learned counsel for the applicants submitted that in order to claim the next promotion to the post of Accounts Officer/Enforcement Officer and also to claim the notional benefits from the date of Organisational and Cadre Restructuring in the Employees Provident Fund Organization, the applicants have submitted the individual representations dated 21.02.2021 (Annexures A-12 and A-13 colly). However, the respondents have failed to take any decision over the said representations uptil now.
2. Learned counsel further submitted that under the compelling circumstances, the applicants have filed the present Original Application and they will be satisfied if a direction is issued to the respondents to decide their pending representations within a time frame.
3. Keeping in view the aforestated limited prayer made by learned counsel for the applicants, we deem it appropriate to dispose of the present Original Application, at the admission stage itself, without entering into the merits of the case.
4. Accordingly, the Original Application is disposed of with a direction to the Central Provident Fund



Commissioner, Employees Provident Fund Organization, New Delhi to decide the applicants' pending representations dated 21.02.2021 (Annexures A-12 and A-13 colly) and pass a reasoned and speaking order in accordance with law within a period of three months from the date of receipt of a certified copy of this order. Before taking such a decision, the applicants shall also be afforded an opportunity of hearing.

5. Ordered accordingly. However, there shall be no orders so as to costs.
