This application having been heard on 19<sup>th</sup> November 2019, the Tribunal on the same delivered the following :

**O R D E R (ORAL)**

**Per : Mr.E.K.BHARAT BHUSHAN, ADMINISTRATIVE MEMBER**

The grievance of the applicant is that despite his name being forwarded and accepted by the Dhanbad Division, he is not being relieved from Trivandrum Division citing large number of vacancies of Track Maintainers in Trivandrum Division.

2. Smt.Shameena Salahudheen, learned counsel for the applicant pointed out that recently 172 Track Maintainers were recruited through RRB and had joined in Trivandrum Division. This fact is not disputed by the learned Standing Counsel for the Railways. Further, it is seen that the applicant is at serial no.30 in the priority list of personnel who are waiting for Inter Railway Transfer. The Standing Counsel for the Railways submitted that it will take time to organise the new personnel who are coming through RRB with necessary instructions and assignment of duties and some more time is required to relieve the applicant from his present charge.

3. After considering all the facts, we direct that the applicant may be relieved from his present charge latest by end of December 2019, to take up his new assignment at Dhanbad Division. The Original Application is disposed of as above. No costs.
