The application having been heard on 22.07.2021, the Tribunal on the same day delivered the following:

ORDER

Per: Mr. P. Madhavan, Judicial Member

The applicants filed this O.A seeking the following reliefs:-

- “i. to direct the respondents to complete the process of selection notified in Annexure A-1 and to operate the select list by appointing the applicants and other similarly situated as Postman in the respective Postal Divisions with all consequential benefits.*
- ii) Grant the cost of the Original Application.”*

2. The applicants in the Select List to the post of Postman open recruitment conducted by the Respondent Department is aggrieved by the delay in finalizing the proceedings by issuing appointment orders in spite of the completion of formalities of recruitment. The applicants are in the Select List published by the Department for appointment of Postman/Mail Guard against

583 vacancies of Postman and 11 vacancies of Mail Guard notified by the Department. The applicants submit that the appointment is not being made merely to favour few GDS and other outsiders officiating in the post earmarked for direct recruitment. Aggrieved by this, applicants filed this O.A.

3. Today, when the case was came up for consideration, learned counsel for the respondents submits that the applicants were already granted the relief and prays for closing the O.A. The counsel for the applicants also admits the same.

4. In view of the above submission, the O.A is closed. No order as to costs.
