ORDER**Mr. Justice L. Narasimha Reddy:**

The applicants in all the OAs and TAs, are appointed to the time scale of KAS at different points of time. The dispute pertaining to the fixation of their inter se seniority, became the subject matter of a long drawn litigation. It becomes necessary to refer to the brief history of these cases.

2. The Jammu and Kashmir Administrative Service (for short "KAS") was constituted in the year 1965. It comprises, of the officers of different stages beginning from Junior Scale and ending with Super Time Scale. The method of recruitment to service and other issues were provided under the 1965 Rules. They were replaced by the Jammu and Kashmir Administrative Service Rules 1979, published on 10.10.1979. According to these rules, the service comprises of (1) Super Time Scale; (2) Special Scale; (3) Selection Grade; (4) Time Scale; and (5) Junior scale.

3. As regards its pattern, it is almost on the lines of the Indian Administrative Service. The appointment to the Junior Scale is exclusively by direct recruitment. The appointment to Time Scale is by way of promotion. Rule 5 (3) provides for filling up of the 65% of the vacancies of the Time Scale posts occurring in

a calendar year, by promotion from departmental feeder services, which are about 16 in number. 10% of the vacancies are to be filled by promotion of officers of outstanding ability and merit, serving in connection with the affairs of the State, but not falling in the feeder services. The remaining 25% of the vacancies occurring in a calendar year are to be filled by promotion of the Junior Scale KAS Officers. Officers of feeder services are made eligible to be considered after completion of four years of service and subject to their vigilance clearance being available.

4. It is stated that the promotion to the time scale of KAS did not take place in the years 2004, 2005, 2006 and 2007 and vacancies referable to all these years were filled up only in the year 2008. Apart from the filling up of the vacancies referable to each year, the Government has also promoted about 49 officers, against leave vacancies.

5. The Government framed KAS Rules 2008, vide notification dated 01.12.2008, bringing about substantial changes in the Administrative Service, in the context of method of appointment and fixation of seniority and replacing the 1979 Rules. The substantial change was by way of introduction of a proviso to Rule 11(3) of the 2008 Rules, which enables

utilization of leave and training resources. The second was in the form of Rule 15 (4), which stated that in case the select list cannot be prepared for the members of any departmental feeding service in any particular calendar year, despite availability of vacancies, the services of the members of such feeding services, though appointed at a later stage, would be reckoned from the date on which the vacancy was allocated to the concerned feeding service. A clause in the proviso was added to it, which is to the effect that the cases of persons appointed against the vacancies of 2004, 2005, 2006 and 2007, shall be reviewed, in terms of Sub-Rule (4), at a subsequent date.

6. The tentative seniority list of officers of Time Scale of KAS appointed between 01.01.2004 and 01.12.2008, as it stood on 01.01.2010, was notified on 21.04.2010, by and large in terms of Rule 15 (4) of the 2008 Rules. The result was that the officers, who are appointed a bit later, were placed above those, who were promoted earlier to them, on the ground that their cases were not considered at the relevant point of time when the vacancies were available, and thereby extending the benefit of Rule 15 (4) of the 2008 Rules. A large number of objections poured in. The common objection was that the seniority must be fixed with reference to the date of induction into service and

not earlier thereto. It was also pleaded that the seniority of the officers must be fixed, with reference to Rule 16 of the 1979 Rules.

7. Placed with the complex situation, the Government appointed a Committee, vide its orders dated 24.09.2020, to examine the issue of fixation of seniority of the members of the KAS appointed to the Time Scale.

8. The committee submitted its report dated 15.02.2011. The main recommendations of the committee were that –

(a) the seniority must be fixed with reference to the 1979 Rules and not the 2008 Rules; and

(b) the date of appointment/promotion to the service and not any other factor, must decide the seniority.

9. Some writ petitions were filed before the Hon'ble Jammu and Kashmir High Court, against the tentative seniority list. When the exercise was pending, the Hon'ble High Court passed certain interim order. Taking the report as well as interim order into account, the Government published a final seniority list dated 24.06.2011, revising the places of seniority reflected in the tentative seniority list and fixing the seniority on the lines indicated by the committee. A batch of writ

petitions was filed challenging the final seniority list dated 24.06.2011.

10. The applicants, who challenged the final seniority list, pleaded that the tentative seniority list was published strictly in accordance with the provisions of law, and in particular, Rule 15 (4) of 2008 Rules and that there was no basis to change it. They contended that though as many as 16 services were treated as feeder category, for promotion to Time Scale of KAS, the officers of some departments were not included in the panel, despite existence of vacancies, and the officers acquired eligibility. According to them, the rules contemplate equitable distribution of vacancies of the Time scale KAS, among various feeder categories and that the imbalance which arose on account of denial for consideration for certain categories, was sought to be corrected, through Rule 15 (4) of 2008 Rules. They submit that the Rule 15(4) and clause (i) of its proviso have a definite purpose to serve and address the issue pertaining to the officers, who are wronged earlier, and that there was no basis either for the committee or for the Government to take the view that the 2008 Rules do not apply for fixation of seniority of the officers appointed between 2004 and 2008.

11. Once there was a flood of writ petitions challenging the seniority list dated 24.06.2011, the Government has chosen to review the entire situation and accordingly appointed a committee, vide order dated 29.05.2020 to look into the various issues, and the committee in turn submitted its report. Taking the same into account, a further revised seniority list was published, vide G.O.No.749-JK (GAD), dated 05.08.2020. These orders are in challenge in two OAs i.e., O.A.Nos.924 and 925/2020, directly, and one TA indirectly. In TA.No.3481/2020, the applicant challenged the validity of Rule 15 (4) of 2008 Rules, and prayed for a direction to the respondents not to take any action under the said provision.

12. The applicants in the subsequent batch of cases contend that induction into Time Scale, takes place, for the first time by way of promotion, from the feeder category service, year after year, and the officers, so inducted, have invariably, to take their seniority, with reference to the places assigned to them by the DPC, coupled with the date of induction. According to them, no officer, who is inducted into KAS by way of promotion, can get the seniority referable to a date, anterior to the one, of his induction. It is also stated that the 2008 Rules, cannot have any bearing upon the fixation of seniority of the

officers, who are promoted much prior to the notification thereof. They further submit that the Rule 15 (4) and its first proviso run contrary to the very fundamentals of service law.

13. It is also stated that there is nothing like fixation of any quota or allocation of vacancies specifically to any feeder category, and the direction, if at all, is only to maintain equitable distribution to the extent possible, and not an allocation with mathematical precision. It is also pleaded that the concept of leave and training vacancies is typical to 2008 Rules, and it cannot be operated prior thereto.

14. Counter affidavits are filed by the Government as well as contesting respondents in the respective TAs and OAs. In certain cases, counter affidavit filed in other similar cases, are sought to be adopted. In a way, the ground, raised in one set of Writ Petitions figure in the counter affidavits filed in other set, and vice versa.

15. In view of reorganization of the State of Jammu and Kashmir, The Writ Petitions were transferred to this Tribunal and they were renumbered as TA.Nos.1325, 3415, 3430, 3439, 3449, 3462, 3467 and 3481/2020.

16. Arguments on behalf of the applicants in the OAs and TAs are advanced by learned counsel Sri R. A. Jan, learned senior advocate Sri Abhinav Sharma; Sri Samer Hassan, Sri Govind Raini, Sri Zaffar Shah, Sri M.Y.Bhat, Sri Vaibhav Gupta and Sri Rahul Pant, and on behalf of the respondents, by Sri Rajesh Thapa, Sri Sudesh Magotra, learned Deputy Advocate General and Sri Amit Gupta, learned Addl. Advocate General.

17. The brief factual background of these cases was furnished in the preceding paragraphs. Coming to the details thereof, the structure of the KAS is provided for under Rule 3 of 1979 Rules and it reads as under:

“3. Constitution of service and its classification

(1) There shall be constituted a Jammu and Kashmir Administrative Service.

(2) The service shall have the following scales of pay, namely:-

(i) Super Time Scale of Rs.5900-6700;

(ii) Special Scale of Rs.4500-5700;

(iii) Selection grade of Rs.3700-5000;

(iv) Time Scale of Rs.3000-4500; and

(v) Junior Scale of Rs.2125-3600:

Provided that the members of the service holding super-time pay scale of Rs.5100-6300 at the commencement of Jammu and Kashmir Administrative Service (Amendment) Rules, 1993,

shall continue to hold the said pay scales in their personal capacities.”

It has already been mentioned that the manner of induction into service is provided for under Rule 5. In a way, Sub-Rule 4 of Rule 3 has also a bearing on this.

18. Rule 5 of 1979 Rules reads as under:

“5. Method of recruitment to the service

(1) Recruitment to the service after the commencement of Jammu and Kashmir Administrative Service (Amendment) Rules, 1993 shall be made by the following methods, namely:-

(a) by a competitive examination at the junior scale;

(b) by promotion to the time scale of the service from amongst the members of the following services holding time scale of Rs.2125-3600 or any other higher grade in the respective departmental service:-

(1) The Jammu and Kashmir Revenue (Gazetted) Service;

(2) The Jammu and Kashmir Secretariat (Gazetted) Service;

(3) The Jammu and Kashmir Co-operative (Gazetted) Service;

(4) The Jammu and Kashmir Excise and Sales Tax (Gazetted) Service;

- (5) The Jammu and Kashmir Industries and Commerce/Handicrafts/Handlooms (Gazetted) Service;
- (6) The Jammu and Kashmir Information (Gazetted) Service;
- (7) The Jammu and Kashmir Tourism (Gazetted) Service;
- (8) The Jammu and Kashmir Labour (Gazetted) Service;
- (9) The Jammu and Kashmir Social Welfare (Gazetted) Service;
- (10) The Jammu and Kashmir CD & NES (Rural Development) (Gazetted) Service;
- (11) The Jammu and Kashmir Employment (Gazetted) Service;
- (12) The Jammu and Kashmir Hospitality, Protocol and Agencies Service;
- (13) The Jammu and Kashmir Food and Supplies (Gazetted) Service;
- (14) The Jammu and Kashmir Transport (Gazetted) Service;
- (15) The Jammu and Kashmir Stationary and Office Supplies (Gazetted) Service;
- (16) The Jammu and Kashmir Administrative Officers (Gazetted) Service.

Note 1. – The Jammu and Kashmir Administrative Officers (Gazetted) Service shall be deemed to be a part of the Jammu and Kashmir Secretariat (Gazetted) Service for working out quota of vacancies in KAS till such time the officers who were

regular recruits of the Jammu and Kashmir Secretariat (Gazetted) Service as on 10.10.1988 are promoted to KAS or retire whichever be earlier. This will not apply to the officers who may be superseded for purpose of promotion to the KAS.

Note 2. – Selections made from time to time for appointment to the service at its time scale shall bear the same ratio, as far as possible, to the number of posts in the respective feeding departmental services.

(c) By selection to the time scale of the service from amongst the persons of outstanding ability and merit serving in connection with the affairs of the State in Departments/Services other than those covered under clause (b) above or in Autonomous Bodies/Government owned Public Sector Undertakings carrying pay scale equivalent or higher than the time scale of KAS, on the recommendations of the concerned department/Autonomous Body /Government owned Public Sector Undertaking respectively.

(2) The number of vacancies in the junior scale of the service to be referred to the Jammu and Kashmir Public Service Commission for recruitment under clause (a) of sub-rule (1) shall be worked out by reference to 25% of the vacancies of senior scale posts available in the year in which the said junior scale recruits shall be eligible for promotion to Time Scale.

- (3) The number of persons to be recruited in the Time Scale of the service under sub-rule (1) from different sources shall be as under:-
- (a) 65% of the vacancies of the Time Scale posts occurring in a calendar year shall be filled up by promotion from the departmental feeding services referred to in clause (b) of sub-rule (1) above;
- (b) 10% of the vacancies of senior scale posts occurring in a calendar year shall be filled up by selection from persons referred to in clause (c) of sub-rule (1) above;
- (c) 25% of the vacancies of the Time Scale post occurring in a calendar year shall be filled up by promotion of the Junior Scale KAS Officers subject to the conditions laid down in sub-rules (4) and(5) of rule 2 hereinabove.

Provided that till the first batch of Junior KAS becomes eligible for promotion to the time scale, the vacancies in the Time Scale of KAs shall be filled up by promotion of officers as specified in clause (b) and clause (c) of sub-rule(1) above in the ratio of 85:15 respectively subject to other conditions as prescribed in these rules.

(Provided further that the Government shall review the position regarding inductions into KAS of officers from feeding services after every interval of five years reckoning from 1st July, 2005 and appoint to its Time Scale eligible members of such feeding services as may have lagged behind in the matter of induction into KAS by operation of any of these rules so as to remove the distortions as far as possible.)”

19. Sub-Rule 4 of Rule 3 deals with the eligibility of the officers of the feeder category and it reads as under:

“(4) Subject to the provisions contained in sub-rule 5, a member of the service appointed by direct recruitment (Junior KAS) and a member from a feeding service shall be promoted to the Time Scale of KAS subject to the following conditions; namely;-

(a) He has completed four years of service in Junior Scale/feeding service as on 1st January of the year in which selection is to be made;

(b) He has passed the departmental examination, if any, prescribed under rules;

(c) The post in the Time Scale of KAS in the relevant service is available; and

(d)The Government is satisfied about his being suitable for promotion to the Time Scale of KAS.)”

20. From the above, it is clear that 65% of the vacancies, occurring in a calendar year in the time scale posts are required to be filled up by promotion from the feeder category services viz., officers, who have completed four years of service in such feeder categories. There is no specific distribution of vacancies of the posts of Time Scale of KAS, among the feeder services. The exhortation in this behalf is only to review the situation after every 5 years recurring from 01.07.2005, as is evident from the second proviso to Sub-Rule 3 of Rule 5.

21. The method of preparation of select list and consequential appointment is provided for under Rules 8 and 9. Rule 10 provides for probation, Rule 11 for training and examination, and Rules 12, 13 and 14 posting of cadre officers. Rule 15 was deleted. The next important provision is Rule 16 dealing with seniority. It reads as under:

“Seniority

- (1) The relative seniority inter se of persons appointed to the service shall be determined on the basis of the order in which names are arranged in the select list prepared under rule 8 of these rules.
- (2) The inter se seniority of those belonging to one and the same feeding service and who have been classified under

rule 8 in the same category shall be determined by reference to their seniority in the feeder service.

- (3) The inter se seniority of those who belong to different services but have been grouped in one class by the selection committee under rule 8 shall be determined by reference to the service rendered at the time scale level of the feeder service. Wherever, the dates of appointment to the Time Scale are the same, the persons higher in age would be given seniority over the younger persons.
- (4) The inter se seniority of the direct recruits on their promotion to the Time Scale, vis-a-vis those appointed by promotion/selection shall be determined in the manner in which the senior scale posts have to be allocated for promotion/selection/direct recruitment as prescribed in the rules. For this purpose a calendar year shall be taken as a unit for determination of the seniority. In case appointment of any group does not take place in a particular calendar year, such a group shall have no claim for relating its seniority with those appointed to the Time Scale in the previous year/years.
- (5) Seniority of the members of the service appointed to at its junior scale through competitive examination shall be regulated under the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules. 1956.”

22. It is clear that the manner in which the seniority of the officers must be fixed, is dealt with exhaustively under Rule 16 of the 1979 Rules. The purport thereof is that basically, the seniority shall be determined with reference to the order in which the names are arranged in the selection list under Rule 8. Sub-Rule (2) deals with the manner, in which, the seniority of the officers from the same feeder category and promoted to KAS time scale is fixed. In such cases, their seniority in the

feeder category would be a determining factor. Sub-Rules 3, 4 and 5 have no relevance to promotion to time scale of KAS.

23. For one reason or the other, promotion to time scale of KAS did not take place in the years 2004, 2005, 2006 and 2007. It was only in 2008, that the DPC was constituted and all the available vacancies were filled up. Consequently, appointments were also made. Before the seniority list of the officers promoted to Senior Scale of KAS between 01.01.2004 and 01.12.2008, was published, the 2008 Rules came into force. Except for small cosmetic changes, the structure of the KAS remained the same under these rules. The method of recruitment is dealt with under Rule 7, which is similar to Rule 5 of 1979 Rules. The percentage allocated among the three categories also remained the same.

24. Rule 14, provides for preparation of list of suitable officers and the method of preparation thereof. Here again, there is not much deviation from the 1979 Rules. An important provision is Rule 15, and it reads as under:

"Rule 15: Appointment to the service in the time scale: (1) The Government shall make appointment to the service in the time scale of persons who are held suitable in terms of rule 14

in the order in which their names appear in the select list for the time being in force.

Provided that the appointment of an officer whose name has been included in the select list but treated provisional under sub rule (3) of Rule 14 shall be made by the government after his integrity has been certified by the respective administrative department having regard to the fact that the officer has been exonerated from the charges which were pending against him at the time of his selection.

(3) All appointments shall be made to the service and not against any specific post included in the cadre of service.

(4) Where select list cannot be prepared for the members of any departmental feeding service in any particular Calendar year despite availability of vacancies owing to the procedural delay such members, when finally included in the select list of any later date shall be appointed to the service from the date on which the vacancy was allocated to such feeding service.

Provided that:

(i) Cases of persons appointed against the vacancies of 2004, 2005, 2006 and 2007 shall be reviewed in terms of sub-rule (4) above if their

appointment has taken place on a subsequent date.

(ii) Persons referred to in sub-rule (4) should otherwise be eligible for appointment to the service under these rules from such retrospective.

(iii) Time scale of the service shall be released to a member of any departmental service who has officiated on a cadre post, or on an equivalent post on an ex-cadre basis, if he is not appointed to the service owing to his retirement provided that a vacancy was available and that he is held suitable by the selection committee for such appointment.

(iv) Cases pending on the commencement of these rules shall also be dealt with in terms of proviso (iii) above.”

25. The innovation is that Sub-Rule (4) of Rule 15 provides that if the select list cannot be prepared for the members of any departmental feeder service, in any particular calendar year, and if such members come to be included in the select list later, their appointment shall be from the date on which the vacancy was allocated to such feeding service. Almost as a supplement to this, Clause (i) to the proviso is added. It enables the Government to review the appointments made against the vacancies of the years 2004 to 2007, in terms of Sub-Rule (4).

This is not a general provision. It can be operated only with reference to the appointments made during a particular period.

26. The next relevant provision of the 2008 Rules is Rule 18 dealing with the seniority. This is on the same lines as is Rule 16 of the 1979 Rules.

27. In this background, the following points arise for consideration:

- (i) Whether the final seniority list dated 24.06.2011, suffers from any legal or factual infirmity;
- (ii) Whether the KAS 2008 Rules, would cover the State of affairs that existed before they came into force;
- (iii) Whether Rule 15 (4) and clause i) of the proviso thereof are legally valid; or whether they are liable to be set aside;
- (iv) Whether the exercise undertaken by the Government in constituting a committee and publishing a further separate seniority list in 2020 is valid and legal; or
- (iv) Whether leave vacancies can be treated as Part of cadre.

Point (i)

28. The broad structure of the KAS and the method of appointment thereto was discussed in the preceding paragraphs. While the induction to the Junior Scale is exclusively through Direct Recruitment, the appointment or induction to time scale is from various sources. 65% is by way

of promotion from 16 feeder categories to the State services, 10% from the persons of extraordinary performance from the services outside those 16 feeder category services, and 25% from the officers of the Junior Scale. While for the officers of Junior Scale, it would be an upward movement in the same service i.e., KAS, for the other category of officers, it would be an induction to it, for the first time, though it is through process of promotion.

29. It is no doubt true that the rules mandate that the exercise of promotion to time scale of KAS is to be undertaken in every calendar year. However, for one reason or the other, the promotions did not take place from the feeder categories, during the years 2004 to 2007. The reasons therefor cannot be reviewed or addressed at this stage. The fact remains that promotions took place, *en bloc*, in the year 2008. Once the officers are promoted, the manner in which the seniority must be fixed is contained in Rule 16 of the 1979 Rules. It is guided by the ranking, or the place, assigned by the DPC. In case, more officers than the one from the same feeder category are promoted, their inter se seniority is to be guided by their seniority in the feeder category.

30. The respondents were under obligation to prepare a seniority list, strictly in accordance with Rule 16 of 1979 Rules. For the officers appointed up to 31.12.2003, a seniority list was published on 16.09.2008. By the time the exercise for preparation of seniority list of officers appointed between 01.01.2004 and 01.12.2009 was taken up, the Government published 2008 Rules on 01.12.2008. The Government has chosen to apply the parameters contained therein, for preparation of the seniority list of such officers. A tentative seniority list was published on 21.04.2010, inviting objections. As expected, 110 representations were received. In view of the complexity involved, the Government appointed a committee, vide Government order dated 24.09.2010. That, in turn, examined the entire Rule position and made the following observations/recommendations on 15.02.2011:

“Whereas, the Committee has, inter alia, made the following observations/recommendations:-

- (i) Seniority can be reckoned only from the date of appointment or date of placement to a post or service and it cannot be reckoned retrospectively from the date of occurrence of vacancy. The Supreme Court in landmark judgments of State of J&K Vs Javed Iqbal Balwan and State of J&K Vs Suraj Prakash

Gupta, has further clarified the position by holding that appointments take effect from the date, a person physically joins the post and that a person cannot claim his appointment from the date when he was not borne on the service to which he has been appointed. Hence, the seniority of an officer has to be determined with reference to the date of appointment and not with respect to the date of occurrence of a vacancy;

- (ii) The service rules and conditions of service of an employee(s) can be amended or altered but not amended or altered retrospectively to his/their disadvantage;
- (iii) The Jammu and Kashmir Administrative Service Rules, 2008 came into force on 01.12.2008 and, therefore, will apply only to inductions to the KAS which were done on or after 01.12.2008. All the officers who were inducted before 01.12.2008 will necessarily have to be governed by the provisions of KAS Rules, 1979;
- (iv) The tentative seniority notified vide Government Order No. 485-GAD of 2010 dated 21.04.2010 has been drawn in terms of the provisions of KAS Rules, 2008 which is incorrect. The seniority of an officer appointed under the KAS Rules, 1979 has to be determined in terms of the provisions of Rule

16 of these rules and not under Rule 18 of the KAS Rules, 2008;

- (v) The Junior Scale KAS officers cannot be given appointment in KAS from a date prior to the date when they had not acquired eligibility for such appointment in terms of the provisions of KAS rules as were in vogue at the relevant point of time. Modification of the provisions of KAS rules by inserting an explanation through a Government order to facilitate the promotion of Junior Scale KAS officers of 2004 batch, cannot have an overriding effect on the basic rule. The said explanation was totally uncalled for. “

31. By the time, the report was submitted, the Writ Petitions were pending, in one of the matters the Hon'ble High Court directed the respondents to consider the feasibility of the fixation of seniority in terms of Rule 15 (4) of the 2008 Rules. Taking all these aspects into account, the Government published final seniority on 24.06.2011. This, in our view, completely accords with the dates of promotion, and other aspects mentioned under Rule 16 of the 1979 Rules.

32. Even on common parlance, an officer would get his seniority only from the date on which he is appointed. Some deviations would be when an officer, who is junior, is

promoted earlier and the promotion of the senior is delayed. Corrective steps are bound to be taken. In such case, though the senior may have been promoted a bit later, compared to his junior, the seniority of the former would be restored.

33. The appointment to the Time Scale of KAS from the feeder category, is by way of promotion. It is an induction for the first time. The occasion to reckon any service rendered on ad hoc basis earlier to the regular promotion or appointment, does not exist in such cases. The induction takes place on being selected and promoted to the Time Scale and not earlier thereto. There is no complaint that an officer, who was appointed on a particular date, was assigned the seniority with reference to any earlier date. We are of the view that the seniority list dated 24.06.2011, fully accords with the KAS Rules as well as general principles of reckoning the seniority. Point no. (i) is answered accordingly.

Points (ii) & (iii)

34. The basis for preparation of tentative seniority list dated 21.04.2010 as well as the redrawn seniority list dated 05.08.2020 is the 2008 Rules, and in particular Rule 15 (4) thereof. The said Rule has already been extracted. Here itself,

we need to take note of the fact that in one of the OAs, that very proviso is challenged.

35. Before discussing further, the doubt as to whether a rule can be made to cover a situation, which existed prior thereto, needs to be addressed. Though it may be akin to one of the making a rule with retrospective effect, on a close analysis, it may not appear to be so. At any rate, except in the case of the law of taxation and criminal laws, no prohibition against enactment of law with retrospective effect, exists. In a given case, service rules, can also be amended with retrospective effect. The only preparation one has to take is that such an exercise should not defeat the accrued rights of the members of the service.

36. Coming to the very purport of the Rule 15, it is evident that sub-Rule (4) contemplates certain situations viz.,

- (a) There exists a provision for allocation of vacancies of time scale, for various feeder categories;
- (b) In a particular year, though the eligible officers of a given feeder category were available and vacancies were allocated, the promotion could not be made for one reason or the other.
- (c) In the subsequent years, the officers, who were eligible in earlier years, were considered and promoted to time scale of KAS.
- (d) In such a case, the officer though promoted at a later stage, would be deemed to have been promoted against

the vacancy, which was available in the preceding or earlier years.

37. To illustrate

- (a) 3 vacancies were earmarked for feeder category of Jammu and Kashmir, Excise (Gazetted) Service in the year 2001;
- (b) Though the eligible officers were available, they were not considered for promotion during that year.
- (c) The officers, who are excluded were considered and promoted in the year 2003
- (d) Notwithstanding the fact that the promotion to the Time Scale of KAS took place in the year 2003, the officers would be deemed to have been promoted in the year 2001.

In examining this, we find that the very first premise does not get support from any provisions of the 1979 or 1980 Rules. It is only the second proviso, Rule 5 (3) of the 1979 Rules, that throws light on this aspect. It reads as under:

“(Provided further that the Government shall review the position regarding inductions into KAS of officers from feeding services after every interval of five years reckoning from 1st July, 2005 and appoint to its Time Scale eligible members of such feeding services as may have lagged behind in the matter of induction into KAS by operation

of any of these rules so as to remove the distortions as far as possible.)”

Even this does not provide for allocation of any specific number of vacancies, for the respective feeder services. The endeavour is only to undertake a broad review, after an interval of 5 years, reckoned from July, 2005. Before such review could take place, the 2008 Rules came into service.

38. The second is that the record is totally silent as to whether any feeder services were allocated the vacancies of time scale of KAS, in any particular year; and that the officers of the concerned departments were denied the promotion. It is only when the record discloses that –

- (a) the promotions took place in a particular year;
- (b) the vacancies that were earmarked for one feeder category were diverted to other feeder category; or
- (c) the officers, who are denied promotion on the previous occasion, were promoted at later point of time;

that the exercise contemplated in Rule 15(4) of the 2008 Rules, can be undertaken.

39. It has already been mentioned that no promotion to the Time Scale has taken place between 2004 and 2008. Further, one cannot take the eligibility of an officer in respect of earlier years, for granted. The reason is that in a particular year, there may be seniors to him, who may have retired by the time the

actual promotion took place. Secondly, it is only the DPC, which can determine the eligibility of the officers with reference to the vacancies of any particular year, and not anyone else. Therefore, Rule 15(4) of the 2008 Rules cannot be sustained in law, both on account of its lacking in factual or legal basis, and its being opposed to the very concept of fixation of seniority.

40. Now comes clause (i) of the proviso to Rule 15 (4). It enables the Government to review the appointments/promotions that took place in certain years. It reads as under:

Provided that:

(i) Cases of persons appointed against the vacancies of 2004, 2005, 2006 and 2007 shall be reviewed in terms of sub-rule (4) above if their appointment has taken place on a subsequent date.

41. Rarely, we come across a provision in an Act or Rule, dealing with the situation referable to a particular type, as does the said proviso. This is not a case, in which the service is being constituted for the first time, and as a transitory provision, certain steps are indicated. The clause enables the Government to review the appointments that took place

against the vacancies of years 2004 to 2007, in terms of Sub-Rule (4). Once Sub-Rule (4) itself is held to be not valid, the proviso has no independent legs to stand. Points (ii) and (iii) are accordingly answered.

Point No. (iv)

42. Basically, once a final seniority list is published, the Government becomes functus officio for all practical purposes. The aggrieved parties have to approach the Court or Tribunal for redressal of their grievance. The respondents did not refer to any provisions of law for undertaking the review of the final seniority list dated 24.06.2011. It has already been indicted that the final seniority list accords with the relevant provision of law as well as the principles governing the fixation of seniority. There is no jurisdiction or even justification, for the Government to appoint a Committee to review the final seniority list, much less to publish the revised seniority list dated 05.08.2020.

Point No. (v)

43. This is as to whether leave and training vacancies can be treated as part of the cadre, and about the place that can be assigned to such officers in the seniority list. The strength of the cadre is clearly defined under the 1979 Rules, and the

promotions/appointments in the time scale are accordingly made. Those rules do not provide for inclusion of any leave or training vacancies for the purpose of promotion. If the Government has to fill the leave and training vacancies by way of promotion of the officers from feeder categories, it can be only as a measure to meet the administrative exigencies, and it cannot be fit into the one, under the rules. Any facility created in this behalf, under the 2008 Rules, does not govern the promotions made, before those Rules came into force.

44. Though the promotions/appointments so made cannot be treated as invalid, such appointees/promotees cannot be placed above those, who are promoted/appointed against regular vacancies. The manner in which the service rendered prior to regular promotion against the time scale of KAS would be governed by the principles laid down by the Hon'ble Supreme Court in Suraj Prakash Gupta and Others v. State of Jammu and Kashmir & Others [(2000 (7) SCC 561)].

45. In view of the discussion undertaken above,

(a) T.A.Nos.3415, 3430, 3439, 3449, 3462 and 3467/2020, wherein the final seniority dated 24.06.2011, is challenged, are dismissed;

(b) The O.A. Nos. 924 and 925/2020, and TA.No.3481/2020 are allowed

- (i) setting aside the order dated 01.02.2000, constituting a committee to review the final seniority list dated 24.06.2011; and the Government order dated 05.08.2020, revising the final seniority list dated 24.06.2011; and
- (ii) holding that Rule 15 (4) of 2008 Rules and Clause (1) of the proviso thereof, are illegal and contrary to law.

There shall be no order as to costs.
