Learned counsel for the applicants submits that the respondents intend to recover the excess of pay allegedly withdrawn by the applicant and as per impugned order dated 30.06.2020 it has been directed that the process be initiated to recover the excess amount drawn by the officials, if any.

2. Learned counsel for the applicants further submits that the O.A. can be disposed of by directing the respondents to issue a show cause notice to applicant before effecting recovery of alleged excess amount.

3. Looking to the arguments of learned counsel for the applicants, the O.A. is disposed of with direction to respondents that before recovering the excess amount drawn by the applicants, if any, notice would be served upon the applicants seeking their explanation regarding alleged excess amount.
