### **ORDER (ORAL)**

**Hon'ble Ms. Manjula Das, Chairman**

#### **MA No.2680/2021**

1. This MA has been filed by the applicants under Rule 4(5) of the CAT (Procedure) Rules, 1987 for joining together in a single Application.

For the reasons mentioned therein, the MA is allowed.

#### **OA No.2100/2021**

2. The applicants have filed the present Original Application under Section 19 of the Administrative Tribunals Act, 1985, seeking the following reliefs:-

(i) *That the Hon'ble Tribunal may graciously be pleased to pass an order of quashing the impugned order dated 27.1.2020 (Annex.A/1), declaring to the effect that not granting the due increment to the applicants as on 30<sup>th</sup> June/1<sup>st</sup> July at the time of retirement of the applicant, for the purpose of granting pensionary benefits to the applicant is totally illegal, arbitrary and against the law of the land and consequently,*



*pass an order directing the respondents to grant the annual increment of the applicants due as on 30<sup>th</sup> June/1<sup>st</sup> July, of the respective year of retirement, for the purpose of granting retirement benefits/pension in the light of Hon'ble Madras High Court judgment dated 15.9.2017 with all consequential benefits/pensionary benefits with interest."*

3. The facts of the case are that the applicants retired on 30<sup>th</sup> June of the particular year after 01.01.2006 and getting their pension from KVS under the provisions of CCS (Pension) Rules. As per amended Rule 10 of the CCS (RP) Rules, 2008, after 6<sup>th</sup> CPC the date of annual increment of all the employees was fixed as on 1<sup>st</sup> July of every year and, therefore, their annual increments were due on 1<sup>st</sup> July of year when the applicants were due for retirement in their respective years of retirement. The applicants contend that since they retired on 30<sup>th</sup> June, the due increment falling on 1<sup>st</sup> July was not granted to them. The applicants submit that an identical issue has been decided by the Hon'ble Madras High Court in WP No.15732/2017 in case of **P. Ayyamperumal vs. The Registrar, CAT & Ors.** which was allowed vide judgment dated 15.09.2017 (Annexure A-3) directing that petitioner would be given one notional increment for the period from 01.07.2012 to 30.06.2013 as he had completed one full year of service though his increment fell on 01.07.2013 for the purpose pensionary benefits and not for any other purpose. The said judgment



has attained finality up to the Hon'ble Supreme Court in SLP (C) Dy. No.22283/2018 decided on 23.07.2018 (Annexure A-4). The applicants submit that an identical issue has also been decided by the Principal Bench of this Tribunal recently in OA No.776/2019 decided on 15.07.2021 (Annexure A-6). The applicants, therefore, seek extension of benefit of the aforesaid judgments.

4. At the outset, Mr. Yogesh Sharma, learned counsel for the applicants submits that recently since the issue involved in this OA as to the grant of annual increment on 1<sup>st</sup> July to those who retired on 30<sup>th</sup> June has already been discussed by the Principal Bench in OA No.776/2019 (supra), the case of the applicants is squarely covered by the same.

5. Per contra, Mr. S. Rajappa, learned counsel for the respondents has relied upon the decision of the Hon'ble High Court of Himachal Pradesh in the case of ***Hari Prakash vs. State of Himachal Pradesh & Ors.*** [CWP No.2503/2016 decided on 06.11.2020] to contend that since the applicants retired one day earlier, they rightly were denied the benefit of one increment.

6. We have heard Sh. Yogesh Sharma, learned counsel for the applicants and Sh. S. Rajappa, learned counsel for the respondents, at the admission stage through video conferencing.



7. We have examined the recent judgment of the Principal Bench of the Tribunal in OA No.776/2019 (supra) and found that the facts and the issue involved in the present OA are identical to OA No.776/2019(supra). We, therefore, dispose of the OA in terms of the following directions as issued in OA No.776/2019:-

- (a) for such of the employees, who retired on 30th June of any particular year, increment payable on 1st July shall be extended. Their pensions shall also be revised, subject to their fulfilling other conditions which are applicable. The arrears that become due shall be paid without interest;
- (b) Similarly for employees, who retired on 31st December of a particular year, the increment payable on the 1st January of the next year shall be extended and pension revised, subject to same conditions in the same manner.
- (c) While extending such benefits, a clause shall be incorporated to the effect that in case the Hon'ble Supreme takes a different view in the Civil Appeal arising out of SLP No. 4722/2021, they shall be under obligation to refund the entire benefit without any demur. The aforesaid exercise shall be completed



within a period of three months from the date of receipt of a copy of this order.

There shall be no order as to costs.
