**ORDER (Oral)****Justice L. Narasimha Reddy, Chairman:**

The Delhi Subordinate Services Selection Board, the 2<sup>nd</sup> respondent herein, issued an advertisement in the year 2014, inviting applications for various posts including Trained Graduate Teacher (Computer Science) (for short TGT (CS)) with Post Code No.192/14. The applicants and several others responded. An examination was conducted and the final results were declared in September 2019. Apart from displaying the list of selected candidates, a waiting panel was also prepared.

2. The applicants contend that though the user departments have returned the dossiers of the several candidates and a quite large number of vacancies existed, the respondents did not operate the waiting list, and thereby, they are being denied an opportunity of being appointed.

3. On behalf of the respondents, a detailed counter affidavit is filed. It is stated that the selection was undertaken for 1025 vacancies under UR, 547 for OBC, 303 for SC and 151 for ST categories. As against such

vacancies, the short listing of candidates was done for 2067 UR, 407 OBC, 607 SC and 92 for ST, and adequate number of candidates under OBC and ST were not available. It is also stated that the applicants were included in the provisional list.



4. The respondents have stated that 1014 vacancies of UR were filled and 11 vacancies were kept unfilled in compliance with the interim order passed by the Hon'ble High Court. As regards, the SC, it is stated that only one vacancy was kept reserved under an interim order.

5. The respondents contend that the wait list lapsed on expiry of one year and no vacancies were available during that period. They further contend that the vacancies that arose due to return of e-dossiers of selected candidates, were also filed with the eligible candidates in the waiting list, who were more meritorious than the applicant.

6. We heard Shri Ajesh Luthra, learned counsel for the applicants, and Ms. Esha Mazumdar and Mr. Anuj Kumar Sharma, learned counsel for the respondents.

7. The selection was to quite large number of posts in the TGT (CS) and the names of the applicants figured in



the provisional list, which was almost double the size of the available vacancies. The particulars furnished in the counter affidavit would disclose that except 11 vacancies under UR and one vacancy under SC, as directed by the Hon'ble High Court, the rest of the vacancies are filled up. For OBC and ST categories, the qualified candidates were not available.



8. The respondents have also filled for the vacancies that arose on account of return of e-dossiers of certain candidates, with candidates in the waiting list, who were more meritorious than the applicants. Under these circumstances, it cannot be said that the respondents have denied the applicants their appointment.

9. We do not find any merit in the OA and the same is accordingly dismissed. Pending MA also stands disposed of. There shall be no order as to costs.
