**ORDER (ORAL)****Mr. Justice L. Narasimha Reddy:**

This Contempt Case is filed alleging that the respondents did not implement the order dated 04.09.2020 in O.A. No.1203/2020. The only direction was to pass orders on the representation made by the applicants.

2. It is brought to our notice that the 1st respondent has passed the orders on 22.10.2020 and the 3rd respondent passed an order on 17.07.2021. With that, the orders in the O.A. stands complied with. If the applicants are not satisfied with the stand taken by the respondents, it shall be open to them to pursue the remedies, in accordance with law.

3. The Contempt Case is accordingly closed.
