## ORDER

### **Justice L. Narasimha Reddy:**

Bharat Sanchar Nigam Limited (BSNL) filed this batch of PTs with a prayer to transfer the OAs pending before the various benches of the Tribunal, to the Principal Bench.



2. It is stated that an order was passed on 23.01.2014, redistributing the posts of DE/AGM level (equivalent to Senior Time Scale) in the Telecom Operation as intermediate arrangement, and some OAs are filed, challenging the said notification. It is also stated that the notification was issued on 11.12.2018 for recruitment of Management Trainees (MT) through internal examination, and that was also challenged in OAs before different benches of the Tribunal. They contend that issues of similar nature, involving the same notification are raised before different benches, and there is every likelihood that conflicting views being expressed by different Benches. Stating to be a step to ensure uniformity and consistency, the BSNL filed this batch of PTs.

3. Notices were ordered and the respondents, who are the applicants in the respective OAS, entered appearance. Some of them have also filed the counter affidavits, opposing the PTs.

4. Today, we heard the arguments of Mr. Pradeep Kr. Mathur, learned counsel for the applicants, Dr. A. Raghu Kr. Brijesh



Mittal, Mr. P. Ramchander Rao, Mr. Kartik Ranjan and Mr. Venkat Raman, learned counsel for the respondents.



5. The effort of the applicants in filing the PTs is to ensure that the issues pertaining to the same notification are examined by a bench at one place so that the possibility of conflicting views being passed is avoided.

6. On behalf of the respondents, serious objection was raised as to the maintainability of the PTs as well as on merits.

7. It is argued that the very purpose of establishing benches at different parts of the country is to ensure that the employees will have access to justice and transferring of all the OAs to the Principal Bench would defeat the very objective. Reference is also made to the judgment of the Hon'ble Supreme Court in **S.P. Sampath Kumar vs. Union of India & Ors.**, 1987 AIR 386.

8. Another argument is that it is not essential that all the OAs may be decided by the Principal Bench, and the transfer of the OAs to the Principal Bench will lead to serious hardship to the respective applicants, in the OAs.

9. The third contention is that in the event of applicants in the OAs suffering any adverse order in the adjudication by the Principal Bench, their right to approach the respective High Courts would be defeated.



10. It is true that the very purpose of establishing the benches at various places is to ensure that the employees at the relevant places will have access to this Tribunal. However, if the notification issued at the highest level in an organization is challenged in different benches of the Tribunal, the possibility of conflicting orders being passed cannot be avoided. In such a case, the issue takes a different turn, and the administration also will not be in a position to take constructive steps. There does exist justification for adjudication of a larger issue having its impact across the country at a place, which, in this case, can be the Principal Bench.

11. Coming to the question of hardship, things would have been different, had it been a case where physical hearing is conducted and the parties or their advocates are required travel all the way to Delhi. As of now, the hearing is taking place through video conferencing, in the Tribunal for the past more than one year. Having regard to the importance of the matter, it can be taken up for hearing through video conferencing, once the records are received. Same advocates, who instituted the proceedings in different benches, can advance arguments.

12. So far as the third ground urged by the respondents, viz. the High Court before which, the proceedings need to be instituted in the event of an adverse order being passed, it can be

addressed, during the course of the OAs, and appropriate orders can be passed.

13. For the foregoing reasons, the PTs are allowed and the respective OAs shall stand transferred to the Principal Bench. Registry shall list all the matters within two weeks and ensure that the record is received in the meanwhile.
