### **Order (Oral)**

**Justice L. Narasimha Reddy**

The applicants felt aggrieved by non-inclusion of the Graduation in B.Ed. as qualification for the post of Assistant Teacher, notified on 12.05.2021. They also challenged the Recruitment Rules insofar as they did not incorporate that qualification.



2. Today, we heard Mr. Naveen Kumar, learned counsel for the applicant and Ms. Esha Mazumdar, learned counsel for the respondents.

3. The very issue fell for consideration before this Tribunal in O.A. No. 2998/2019. Vide order dated 10.10.2019, we dismissed the said O.A. and declined to interfere with the Recruitment Rules as well as the Notification. It is represented that a Writ Petition filed against the said order is pending before the Hon'ble High Court, no interim order was passed therein. Therefore, we dismiss the O.A. following the judgment in O.A. No. 2998/2019 dated 10.10.2019.
