The present Application has been filed by the applicants seeking withdrawal of O.A. No. 1052/2021.

Mr. Ankur Chhibber, learned counsel for the applicants, on being instructed by his clients, submitted at the Bar that the respondents are in the process of consideration of the claim of the applicants. Accordingly, he sought permission of the Tribunal to withdraw the O.A. However, liberty may be granted to them to seek remedy, if the applicants are not satisfied with the decision of the Authority.

3. Permission is accorded. Accordingly, the M.A. is allowed and the O.A. is dismissed as withdrawn, with liberty as aforesaid. Pending MA also stands disposed of. There shall be no order as to costs.
