O R D E R (ORAL)

Justice L. Narasimha Reddy, Chairman :

The applicants submitted a representation with a prayer to direct the respondents to extend them the benefit of upgradation of grade pay of Rs.5400/- on completion of four years of service in the grade of Rs.4800 w.e.f. 01.01.2006 whichever is later.

2. Today, we heard Mr. Padma Kumar S., learned counsel for the applicants and Mr. Y.P. Singh, learned counsel for the respondents.



3. The applicants contend that though there exists clear instructions in this behalf, the respondents are not taking any steps.

4. Identical issue was dealt with by us in OA No.3074/2019 and batch, dated 31.10.2019. Having regard to the complexity of the matter, we directed the respondents therein to pass orders on the representations made by the applicants.

5. Following the same, we dispose of this OA with a direction to the respondents to pass orders on the representations submitted by the applicants, claiming extension of the benefit of grade pay of Rs.5400/- on completion of four years of service. We make it clear that we did not express any views on the merits of the case.

Pending MA also stands disposed of. There shall be no order as to costs.
