ORDER (Oral)



Hon'ble Mr. R. N. Singh, Member (J):

The applicants, 103 in numbers, have filed the present OA under Section 19 of the Administrative Tribunals Act, 1985, praying therein for the following relief(s) :-

“8.1 To quash & setaside the result of PE&MT of applicants herein only conducted on 30.06.2021 whereby the applicants has been ‘Disualified’ in PE & MT of present selection process.

8.2 To direct the respondents that PE&MT in respect of applicants herein be-reconducted on any reserve days i.e. fixed on 27.07.2021 to 09.08.2021 in present selection process and if qualified then applicants herein be given appointment to the post of Constable (Exe.) in present selection process with all consequential benefits including seniority & promotion and pay & allowances.

8.3 To direct the respondent to bring the records/video-graphy of PE&MT in respect of applicants herein.

Any other relief which this Hon'ble court deems fit and proper may also be awarded to the applicant.”

2. Learned counsel for the applicants submits that for redressal of their grievances, the applicants have preferred representations dated 06.07.2021 (Annexure A/1 Colly.) and the same have been posted on 07.07.2021.

3. The applicants have also filed MA No.1689/2021 seeking permission for filing of the aforesaid OA jointly.

4. Issue notice. Learned counsels, who appear for respondents on advance service, accept notice.



5. At the outset, Ms. Esha Mazumdar, learned standing counsel appearing for respondent nos.1 to 4, submits that OA No.1324/2021 was listed before the coordinate Bench today and the same has been disposed of with liberty to the applicants therein to make a representation for redressal of their grievances before the respondents and on receipt of such representations, the respondents have been directed to consider and dispose of the same by passing an appropriate reasoned and speaking order. She submits that if such Order is passed in the present OA as well, the respondents shall have no objection.

6. In view of the aforesaid, without going into the merits, the present OA is disposed of with direction to the respondents to consider the applicants' aforesaid pending representations dated 06.07.2021 (Annexure A/1 Colly.) if the same has been received by them and dispose of the same by passing an appropriate reasoned and speaking order as expeditiously as possible and in any case within a period of a week.

7. Pending MAs also stand disposed of, accordingly. No costs.
