**ORDER (Oral)****Hon'ble Mr. R. N. Singh, Member (J):**

The present CP has been filed alleging willful defiance of the directions of this Tribunal in order/judgment dated 23.09.2019 (Annexure C-1). The operative portion of the order/judgment dated 23.09.2019 reads as under:-

*"4. In view of the above factual situation, without going into the merits of this case, the applicants are directed to submit a detailed and fresh representation to the respondents which shall also include the judgments relied upon by them within a period of 15 days of receipt of a copy of this order. The respondents thereafter shall pass a reasoned and speaking order on the said representation within a period of 90 days of receipt of such representation.*

*5. With the above directions, the OA stands disposed of at the admission stage itself."*

It is not in dispute that pursuant to the directions of this Tribunal, the respondents have passed an order dated 16.04.2021, a copy of which is stated to have already been supplied to the petitioner/petitioner's counsel. A copy of the said order is also on record.

We are of the considered view that the directions of this Tribunal have substantially been complied with. Accordingly, CP is closed.
