O R D E R (ORAL)

Justice L. Narasimha Reddy :

The applicants initially joined the service of the Directorate of Education, Government of Delhi, as a Primary Teachers. Thereafter, they were promoted to the post of Trained Graduate Teacher (TGT), and they had experience of about five to six years, in that post.

2. The Directorate of Education requisitioned the UPSC to select the candidates for about 360 posts of Principal. Accordingly, the UPSC issued an advertisement on 24.04.2021 duly stipulating the qualifications as to the educational qualifications as well as the experience. In addition to holding the educational qualifications, the candidates are required to have the experience of 10 years of Post Graduate Teacher (PGT) or Vice Principal or TGT.

3. The applicants contend that if their standing as Assistant Teacher, is taken into account, they would also complete 10 years and the rules, insofar they do not provide for counting of service as Primary Teacher are arbitrary and illegal. They filed this OA with a prayer to quash the Recruitment Rules published on 10.01.2019 stipulating the experience of 10 years only in the post of Vice Principal, PGT and TGT and not in the post of Assistant Teacher. They have also prayed for quashing of advertisement dated 24.04.2021, which incorporated the



same qualifications and also sought for a direction to the respondents to consider their cases for the post of Principal.

4. The applicants contend that their experience in the post of Assistant Teacher is of utmost utility, particularly, when the posts of Principal are sought to be filled for the very institutions, where they worked. It is also stated that when the distinction between the PGT and TGT is blurred in the context of experience, there is no reason to maintain the distinction between the TGT and Assistant Teachers. Various other contentions are also urged.

5. We heard Shri Manish Verma, learned counsel for the applicant and Ms. Esha Mazumdar, learned counsel for the respondents, at the stage of admission.

6. The advertisement was issued initially on 24.04.2021 stipulating the last date for receipt of applications as 31.05.2021, but on account of Covid-19, the advertisement was kept on hold for some time and recently, the receiving of applications started. The eligibility stipulated for the post is in terms of educational qualifications as well as experience. The qualifications are as under:-

“ESSENTIAL:

I) **MASTER’S DEGREE FROM A RECOGNIZED UNIVERSITY/INSTITUTE**



- II) BACHELOR OF EDUCATION FROM A RECOGNIZED UNIVERSITY/INSTITUTE AND
- III) TEN YEARS' EXPERIENCE OF TEACHING (VICE PRINCIPAL/POST GRADUATE TEACHER/TRAINED GRADUATE TEACHER) IN A RECOGNISED HIGH SCHOOL/HIGHER SECONDARY SCHOOL /SENIOR SECONDARY SCHOOL /INTERMEDIATE COLLEGE)”

The same qualifications are mentioned in the advertisement also.

7. It is fairly well established that it is always for the Appointed Authority to stipulate the qualifications for any post, on its establishment. The qualifications are stipulated, duly taking into account, the requirement of the job and the parameters of proficiency. Once the respondents have chosen to stipulate 10 years of experience in the categories of Vice Principal, PGT and TGT, it is just un-understandable as to how the applicants can insist on widening the scope of the recruitment rules, to include the experience in the post of Assistant Teacher also. The post of Principal happens to be very important, both in terms of the administration and academic activities. It is not for the Tribunal to substitute its views and to expand the scope of the recruitment rules.

8. Things would have been different altogether, had the applicants cited any provision of law which can be said to have been contravened by the rules. No such provision is cited.



9. We do not find any merit in the OA and it is accordingly dismissed. Pending MAs also stand disposed of. There shall be no order as to costs.
