Heard learned counsels for both the parties.

2. This OA has been filed to seek the following relief:

*"8(i) An order do issue directing the respondents to fix the pay of the applicant by granting one increment with effect from 01.01.2016 and also to grant arrears."*

4. During the course of hearing, learned counsel for applicants submits that applicant would be satisfied, if applicants are granted liberty to file individually <sup>file</sup> a comprehensive representation<sup>file</sup> asking the same relief before the department and the authorities may be directed to consider the same in the light of applicable rules/guidelines and to pass a reasoned and speaking order within a stipulated time frame.

5. Learned counsel for respondents does not have any objection if such direction is given but the same shall be considered as per applicable rules.

6. In view of the above, O.A. is disposed of with liberty to applicants to file a comprehensive representation individually before the department/respondents and the respondents/competent authority shall consider and dispose of the same in the light of applicable Rules/Guidelines by passing a reasoned and speaking order within a period of four months from the date of receipt of copy of this order. It is made clear that we have not entered into the merit of the matter.



7. Accordingly, All the OA& MA stand disposed of. No costs.
