**ORDER**

**Bidisha Banerjee, Judicial Member**

The O.A.350/1435/2020 has been preferred to seek the following reliefs:-

- "a) Liberty may be granted under Rule 4(5)(a) of Central Administrative Tribunal(Procedure) Rules, 1987 to file and maintain the Original Application jointly;*
- b) To expunge the cadre of Track Maintainer from the ineligible category as per Notification dated 10.11.2020 issued by the DRM, Eastern Railway;*
- c) To direct the respondents to declare the Track Maintainer cadre specially Track Maintainer-IV in G.P. of Rs.1800/- as eligible category to participate in the selection procedure for the post of Office Clerk Gr.II-cum-Typist in Level-02 of Pay Matrix;*
- d) Any other order or orders as the Hon'ble Tribunal deems fit and proper."*

2. The applicants have also preferred M.A.No.350/715/2020 seeking permission to move the O.A. jointly under Rule 4(5)(a) of

Central Administrative Tribunal (Procedure) Rules, 1987, which is allowed.

3. At hearing, Id. counsel for the applicants would submit that the applicants in this case made a representation dated 09.12.2020(Annexure A/2) to the Divisional Railway Manager, Eastern Railway, Howrah ventilating their grievances therein and prayed for inclusion of Track Maintenance cadre to participate in the selection for the post of Office Clerk Gr.II cum Typist by declaring the same as eligible category, but their representation has not yet been considered. On our query, Id. counsel would submit that he would be satisfied if a direction is given to the competent authority to consider and dispose of the representation as per law within a time frame.

4. Id. counsel for the respondents has no objection to such prayer made by Id. counsel for the applicants.

5. In view of the submissions made by both sides, the Respondent No.3 i.e. the Divisional Railway Manager, Eastern Railway, Howrah or any other competent authority is directed to dispose of the representation of the applicants keeping in view the relevant rules and regulations in force, within a period of 2 months from the date of receipt of a copy of this order.

6. It is made clear that we have not gone into the merits of the case and all the points are kept open for consideration by the respondents as per rules.
