ORDER

ORAL

(Delivered by Hon'ble Mr. Rakesh Sagar Jain, Member-J)

The present O.A. has been filed against Order No. 03 dated 07.08.2020 passed by the Principal/Dean, Government Medical College, Srinagar issued vide endorsement no. Legal/MC/Sgr/97-101 dated 07.08.2020; in terms of this order, purportedly consideration stands accorded to the claim of the applicants in compliance to orders passed by this Tribunal in OA No. 202 of 2020 titled Hilal Ahmad Bhat & Ors Vs Union Territory of J&K and ors, whereunder the claim of the applicants vis-à-vis release of arrears of pay has been rejected.

2. Learned counsel for the applicants submits that the applicants would be satisfied, if a direction is issued to the respondents to treat this O.A. as representation preferred by the applicants and take a decision on the same by passing a reasoned and speaking order within a stipulated time frame.

3. We have heard Mr. M.I. Dar, learned counsel for the applicant and Mr. Amit Gupta, learned A.A.G. for the respondents and perused the records.

4. Looking to the facts and circumstances of the case as well as limited prayer made by the learned counsel for the applicant, the O.A. is disposed of with direction to the



respondents to treat this O.A. as representation preferred by the applicants take a decision on the same by passing a reasoned and speaking order within a period of two months from the date of receipt of certified copy of this order. While taking a decision the respondents would also take into account the order no. HME/Accts/127/2018-I dated 10.04.2019 (Annexure No. A-6 to the O.A.), letter dated MC/Accts/579-80 dated 26.06.2019 (Annexure No. A-7 to the O.A.) and letter dated MC/Accts/392-93 dated 28.12.2019 (Annexure No. A-9 to the O.A.) passed by them.

5. It is made clear that we have not entered into the merits of the case.

6. There shall be no order as to cost.
