## ORDER [ORAL]

## (Delivered by Hon'ble Mr. Anand Mathur, Member-A)

At the outset, learned counsel for the applicants submits that the O.A. can be disposed of by directing the respondents to consider the O.A. as representation of the applicants and take a decision on the same by passing a reasoned and speaking order within a time frame.

- 2. Learned A.A.G. has no objection, if such a direction is given.
- 3. We have heard Mr. Showkat Ahmad Makroo, Sr. Advocate assisted by Mr. Danish Yousuf, learned counsel for the applicants and Mr. Amit Gupta, learned A.A.G. for the respondents and perused the records.
- 4. Looking to the limited prayer made by the learned counsel for the applicants, the respondents are directed to treat this O.A. as representation of the applicants and take a decision with regard to the request of the applicants for regularization provided posts are available under Rules and as per existing schemes. Let this exercise be completed within a period of three months from the date of receipt of a certified copy of his order.
- 5. It is made clear that we have not entered into the merits of the case.
- 6. No order as to costs.
