ORDER [O R A L]

Hon'ble Mr. Rakesh Sagar Jain, Member (J):

At the outset, learned counsel for the applicants submits that the respondents may be directed to consider the case of applicants for promotion to next higher post of Inspector within a stipulated period of time. He further prays that the respondents may also be directed to take a final decision on the recommendation made by the Inspector General of Police, U.T. Ladakh dated 14.03.2020.

Looking to the arguments of learned counsel for the applicants, the O.A. is disposed of with a direction to the respondents to consider the case of applicants for promotion and also to take a final decision on the recommendation made by the Inspector General of Police, U.T. Ladakh dated 14.03.2020 within a period of one month from today. While deciding the case of the applicants, the respondents will consider the O.A. as representation. Till the representation is decided, fresh promotion will not be given.

3. It is made clear that we have not expressed any opinion on merits of the case while disposing of the present OA.
