2. Heard him on admission of the OA. He has not brought on record order or circular of the Staff Selection Commission by which the list of recommended candidates for appointment by CRPF was notified. Further, on

perusal of the OA we find that none of the papers/documents attached with it has been attested to be certified copy of the original document.

3. In view of these defects, the OA cannot be admitted in present form. So the applicants' counsel seeks permission to withdraw this OA and to resubmit a properly drafted OA.

4. Hence this OA is dismissed as withdrawn. The applicants may file a properly prepared OA on their grievance, if they so wish.
