3. MA No.279/2021 seeking permission to file
this OA as Joint Petition is allowed.

4. The main contention of the applicants in this
OA is that they have not been accorded parity in
pay scale with other fire services cadres such as
the fire service under the Government of Delhi.
For this, they have submitted a representation to
respondents dated 14.09.2020 which is yet to be
decided.

5. The applicants' counsel requests for
directions to the respondents to decide this
pending representation within a specified time
frame.

6. In view of the above submissions, the Original Application is disposed of at the admission stage itself with directions to the respondents to consider the pending representation of the applicants dated 14.09.2020 as per the relevant provisions of applicable rules and law, and decide it by passing a reasoned and speaking order within a period of three months from the date of receipt of certified copy of this order and thereafter within a week communicate it to the applicants. No order as to costs.
