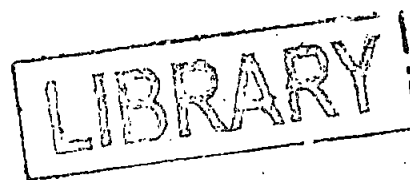

This Review Application has been moved by the applicant seeking review of the order dated 21.12.2020 passed by this Tribunal in M.A.351/01/2016 to the following extent:</p> <p><i>"i. An order be passed to review the order dated 21.12.2020 passed by this Hon'ble Court in M.A. No. 351/01/2016 in O.A. No. 351/170/2014 whereby this Hon'ble Court disposed of the Miscellaneous Application with the direction to the respondents to dispose of the claim of the applicant and to pass appropriate order in terms of the original order passed in O.A. No. 351/17/2014 dated 21.03.2014 within a period of three months.</i></p> <p><i>ii. An order be passed directing the respondents to dispose of the claim of the applicant and to pass appropriate order in terms of the original order passed in O.A. No. 351/170/2014 dated 11.06.2015 within a time frame.</i></p> <p><i>iii. Any other order/orders, further order/orders as your Lordship may deem fit and proper in the ends of the justice."</i></p> <p>3. Ld. Counsel for the applicant submits that in the order dated 21.12.2020, the Original Application No. has been shown as 351/17/2014 and the date of order has been reflected as 21.03.2014 whereas the actual Original Application is O.A.No. 351/170/2014 and the date of order is 11.06.2015. Accordingly, he has prayed for review of the aforesaid order.</p> <p>4. Having heard Ld. Counsel for the parties, the order dated 21.12.2020 passed in M.A. No. 01/2016 is reviewed and modified to the following extent:</p>
